# **EXPERIENCE IN INTELLECTUAL PROPERTY**

Has been working in the field of intellectual property in Ukraine since 2006. While working in this sphere handled a number of cases ranging from copyright and trademark rights violations, including over the Internet, to domain name disputes litigations. Practice, inter alia, encompasses a wide range of intellectual property issues, i.e. IPRs enforcement, protection of trademarks, patents and copyright, as well as general corporate matters; IP/IT contractual practice; compliance and regulatory matters in the field of personal data protection; unfair competition, advertising, media and e-commerce etc.

Being a litigation lawyer is involved in a number of IP court cases representing famous brand owners in defending their IP rights in Ukraine. In particular, acted as attorney-at-law in over 40 court cases in courts of first instance and appellate courts in Ukraine from 2005 to the present. Subject matter of the court cases concerned trademark infringement and non-use trademark termination (26), design infringement (3), copyright infringement (3), general disputes (10).

Except of court representation, is also focused on domestic and international trademark and copyright matters including trademark portfolio advice and counseling, prosecution and IP protection to a wide range of businesses particularly a leading company providing passenger carriage services; a luxury watches and accessories company; worldwide known pharmaceutical manufacturers; innovative company providing field management and vegetation control system; famous worldwide electronics company etc.

Has been engaged as an attorney-at-law in a number of trademark infringement cases the subject matter of which is use of a trademark in a domain name.
