- ❖ **(2022) Reconstruct XML of ‘Composition and Physical Properties of Alloys’**
 - **KIPO’s own standard → ST.96 v6.0**
- ❖ **(2023) Shorten update cycle of ‘Administrative Documents’
from Weekly to Daily**
 - **Notice of Allowance, Notification of Reason for Refusal, Notification of Refusal**
