Statement of DPRK delegation -

It is essential to give considerable attentions to the developing countries in drawing up their own national IP strategy and developing their infrastructure.

In this regard, developed countries should fulfill their commitment of financial support and fully support the technical assistance of WIPO, allow technology transfer to developing countries without any preconditions.

At the same time, successful implementation of development agenda and cooperation South-South should be enhanced to narrow the gap between the north and south and deter any social problems such as brain drain.

Regarding to the "Design Law Treaty" under discussion, the delegation of the DPRK fully supports the request made by several countries to state the technical assistance for developing countries.

Finally, the DPRK takes this opportunity to express expectation that the WIPO will strengthen the cooperation with international organizations including UNESCO, UNEP and WHO and continues to pay attention to the tendance of politicization of projects and activities.
