Acting as attorney, council, expert and legal advisor in the area of intellectual property, copyright, in particular, since 1987;

In the area of international copyright law, has been advising among others, the International Intellectual Property Alliance (IIPA, Washington), International Federation of the Phonographic Industry (IFPI, London) and the Business Software Alliance (BSA, Washington) and other private clients;

In 1992, was appointed as the head of the working group in the Russian Parliament for the new Law on Copyright and Neighbouring Rights and a member of the working group for other intellectual property laws in Russia. In 1994-95, acted as the leading expert of the Russian Parliament for the introduction of legislation on new enforcement sanctions (criminal and administrative) in the area of intellectual property. Later, participated in drafting new customs measures for intellectual property protection as a part of the Russian Customs Code;

On behalf of the World Intellectual Property Organisation (WIPO, Geneva) advising on the CIS countries and was responsible for developing model provisions for copyright and neighbouring rights for this region. Also, consulted with the governments of Ukraine, Belarus, Kazakhstan and other CIS countries during the process of drafting their new copyright laws. Has represented the Russian government at several WIPO Diplomatic Conferences, the World Trade Organisation (WTO) Working Party on TRIPs and intellectual property meetings at the World Customs organization (WCO). Has also served as a member of numerous high level Russian delegations visiting the United States, the European Commission, WIPO, WTO, WCO and other international organizations.
