关于第50号任务的报告

第七部分工作队编拟的文件

导 言

- 1. 在 2016 年 3 月举行的第四届会议续会上,产权组织标准委员会(CWS)同意设立第 50 号任务,即"确保对产权组织《工业产权信息与文献手册》第七部分公布的调查进行必要的维护和更新",并同意组建一支相关工作队(第七部分工作队)。国际局被指定为工作队牵头人(见文件 CWS/4BIS/16 第 73 段和第 122 段(e)项)。
- 2. 在2018年举行的第六届会议上,标准委员会批准了关于授予和公布补充保护证书(SPC)以及专利期延长(PTE)的调查问卷。标准委员会请秘书处发出通函,邀请各工业产权局参与关于授予和公布补充保护证书以及专利期延长的调查,并要求国际局编拟并公布更新后的第7.2.4部分。标准委员会还要求第七部分工作队就更新关于已公布文件编号和已注册权利编号的第7.2.2部分编拟问卷,并在其第七届会议上提交提案以供审议。(见文件 CWS/6/34 第154 段至第160 段。)

进展报告

- 3. 2018年12月,国际局公布了关于介绍优先权申请编号情况的《产权组织手册》第7.2.4部分的更新。第7.2.4部分载有48个工业产权局的答复,以及十二个工业产权局在答复最新调查时提供的更新后的信息。
- 4. 第七部分工作队按标准委员会的要求,开展了关于授予和公布补充保护证书以及专利期延长的调查。调查结果在标准委员会第七届会议上提交以供审议。(见文件 CWS/7/23。)

- 5. 第七部分工作队就更新关于已公布文件编号和已注册权利编号的第7.2.2部分编拟了调查问卷草案。调查问卷文本在本届会议上提交以供批准。(见文件 CWS/7/24)。
- 6. 第七部分工作队还更新了关于更新《产权组织手册》第七部分的近期活动和工作计划及暂定日程,作为本文件附件提交。标准委员会第七届会议和第八届会议之间的进度安排包括:公布上述关于补充保护证书以及专利期延长的调查结果;更新关于已公布文件编号和已注册权利编号的第 7.2.2 部分以及关于专利文献范例与类型的第 7.3 部分;并编拟关于更新日历日期表示方法的第 7.1 部分的调查问卷草案以及关于专利公报中著录项目信息的第 7.6 部分的调查问卷草案,向标准委员会第八届会议提交。
