
Part 7.9: Survey concerning citation practices in industrial property offices (December 2008)

Did not update previously published pdfs, as this has not been CWS practice. For instance, pdfs published before 2010 still have old WIPO logo.



- Plan to present proposal at CWS / 11



Part 8 last updated in 2013 (glossary) and 1994 (abbreviations)



- International Bureau compiling a list of relevant terms from ST.96 and other sources for possible updates to part 8
- Will need IPOs to review in 2023 and reach agreement on changes to propose at CWS / 11



Website changes

- WIPO planning to update website publishing platform, styles, and content
- Secretariat will monitor impacts on CWS, Standards,Handbook pages



Other improvements

- Further improvements to Handbook will be considered after website refresh, such as layout of Part 7
- Exploring publishing standards and other Handbook documents in html, with pdf also available
