## 2. Customer

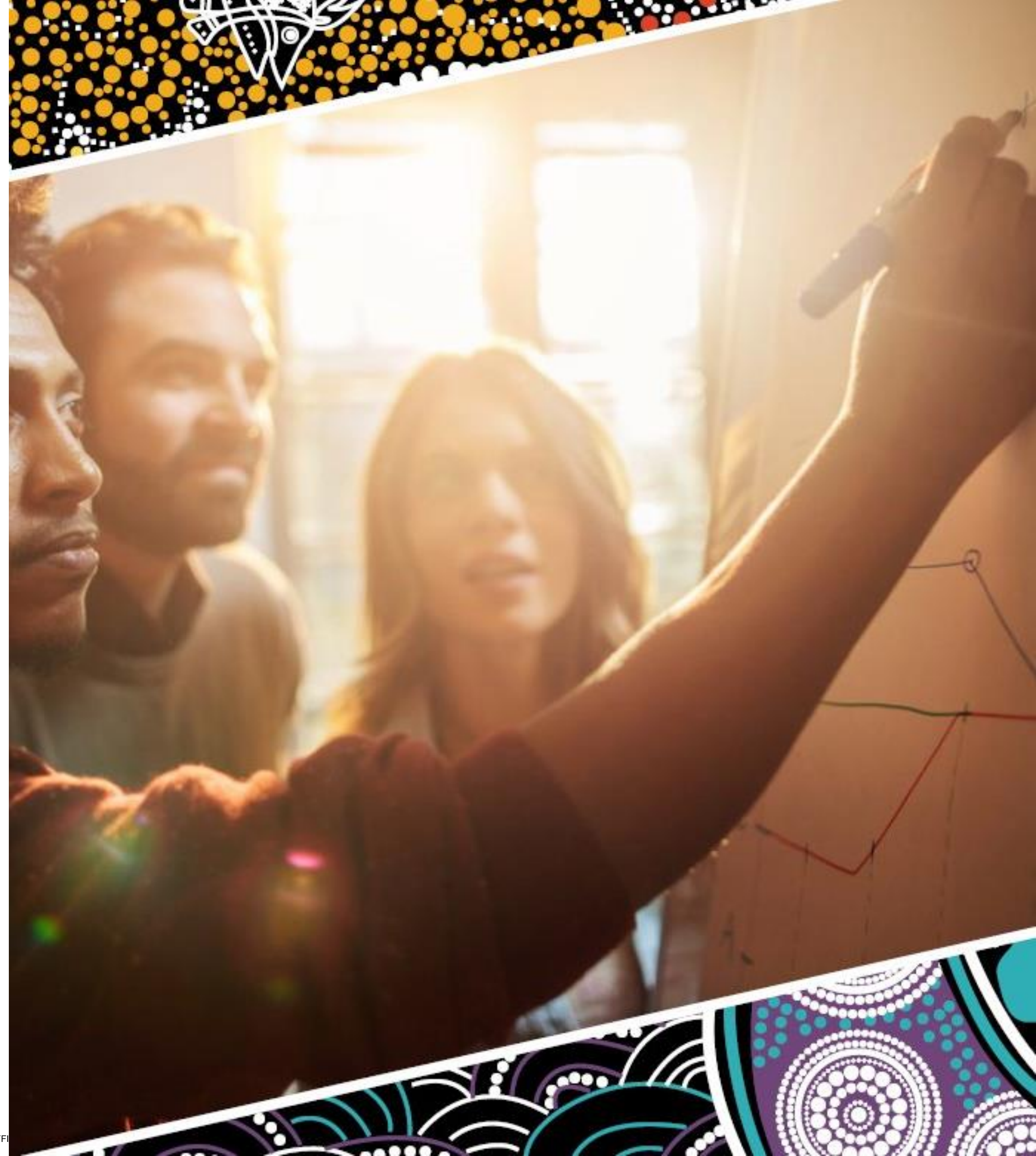
- 2.1 Increase customer experience excellence in the delivery of IP rights services

- 4.2 Provide continually improving contemporary digital customer services and staff experiences

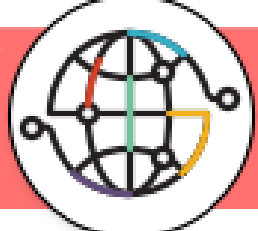



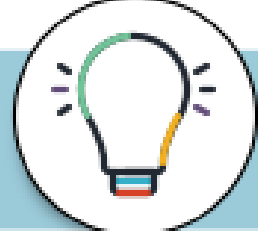
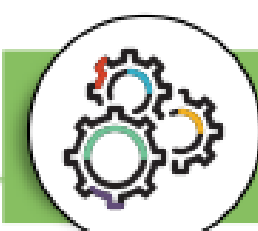
