Task Force

- 6th CWS: noted 40 Recommendations prepared by the Meeting on ICT Strategy and Artificial Intelligence
- 8th CWS: task force priority of 40 recommendations

Priorities

 R09 (collaboration on emerging technologies), R18 and R4 (conversion to XML), R06 (reingeniering and digital transformation), R23 (AF), R39 (online services via APIs), R12 and R15 (distributed IP register, blockchain), R38 (standard APIs for data dissemination)

- Robotic pilot project
 - ✓ Three phases:
 - Discovery
 - Procedures prioritization (and selection)
 - Implementation
 - ✓ Pilot 1: RPA on premise
 - ✓ Pilot 2: RPA on cloud infrastructure
- Evaluation of Low Code solutions

- EPO new Frontoffice efiling for Patents for member states (pilot). Replace former eOLF service
- EUIPO IP Register Blockchain. We have moved TMVIEW to CTI platform to integrate to blockchain network

We started questioning our effiency...

Are we receiving the right productivity from our vendors?

Then we realized that we had to work towards the following lines of action:

01

OBJECTIVE & AUDITABLE METHOD

Function points is the selected method because:

- It is based on the software product and ISO/IEC standard
- ✓ It is objective, transparent, auditable and endorsed by the European Comission
- Supports market benchmarking using a reference database.

02

BENCHMARKING

Control of the User Stories effort through a method of estimation comparable with the market to know the situation with respect to:

- How do our vendors perform compared to the market?
- What savings and productivity improvements can I achieve?

03

CENTRALIZED ESTIMATION PROCESS

Launch a centralized process through an App that simplifies it, defining:

- ✓ A common workflow of estimation
- ✓ Compulsory use of the methodology
- ✓ Detailed breakdown of estimates
