**Benjamin HUGHES** 

Independent arbitrator and mediator, and associate professor of law at Seoul National University Presentation 1. Practical Considerations for the Resolution of IP Disputes: ADR versus Litigation

Mr. Benjamin Hughes is an independent arbitrator and mediator, and associate professor of law at Seoul National University. Mr. Hughes was educated in both the civil law and the common law traditions, having studied first at SNU College of Law (MA Course, all coursework in Korean), and then at NYU School of Law (J.D.).

Mr. Hughes ceased practice as a lawyer in March 2013 to focus on his practice as an independent arbitrator and mediator. Since then, he has been appointed in arbitrations under the rules of the ICC, SIAC, HKIAC, UNCITRAL, CIETAC, ACICA and KCAB. He has also conducted mediations, both in English and in Korean.


# **Presentation 3. Update on Domain Name Dispute Resolutions including New gTLDs**

Mr. Ho-Hyun Nahm is the lead partner of Barun IP & Law in Seoul, Korea. Mr. Nahm was admitted to the Korean National Patent Bar as Patent and Trademark Attorney in 1986. He has been specializing in contentious and non-contentious patent and trademark matters as well as international licensing.

He is the Vice President of the Korea Arbitrators' Association and an arbitrator of the Korean Commercial Arbitration Board. He also serves as the Director of the Korean Intellectual Property Forum, the Korean Industrial Property Rights Institute, and the FICPI-Korea.
