

REQUEST FOR THE RECORDING OF A LIMITATION

IMPORTANT

1. You can request the recording of a limitation for **one** international registration **per form**.
2. The request must relate to only **some** of the designs covered by the international registration. If the request concerns all designs covered by the international registration, use [form DM/5](#) (renunciation).
3. The limitation to the designs can only be recorded for the **same** designated Contracting Parties.
4. All fields are **mandatory** unless indicated otherwise.
5. Complete this form electronically; WIPO cannot accept handwritten forms.
6. Avoid printing and scanning this form. Upload the completed and signed form directly to WIPO through [Contact Hague](#).
