By focusing on innovative solutions to pressing issues such as unemployment, education and health care, social entrepreneurs are able to mobilize the potential of the youth, driving forward both economic growth and societal well-being. This demographic advantage, when coupled with the inclusive and sustainable approach of social entrepreneurship, can indeed be a strategic asset for countries like Turkey, paving the way for a future where economic development is closely aligned with social progress.

Social entrepreneurs are known for their innovative approaches to addressing complex social issues. In economically developing countries, these innovations can offer solutions to challenges such as health care, education and environmental sustainability, which traditional models have not adequately resolved. Economically developing countries often face unique challenges related to unemployment, poverty and social inequality. Simultaneously, they possess a demographic advantage in the form of a youthful population, which can be harnessed as a valuable resource for societal and economic progress. This demographic can be a strategic asset for social entrepreneurship.

For instance, the British Council's report on the state of social enterprise within Turkey highlights the sector's potential, driven by young, purpose-led businesses predominantly founded and managed by women. These enterprises are making strides in education, manufacturing and the creative industries, leveraging Turkey's significant youth demographic. The report underscores the importance of a supportive policy context and a growing ecosystem for social entrepreneurship, showcasing Turkey's commitment to addressing social needs through innovative business models. Turkey's demographic landscape is marked by a median age of approximately 31 years, making it a nation with a significant youth population (World Bank, 2020). This demographic presents both opportunities and challenges, and social entrepreneurship initiatives in Turkey have been instrumental in harnessing the potential of the youth and this illustrates how social entrepreneurship can harness the potential of the youth to drive economic growth and social change. By focusing on innovative and sustainable solutions to societal challenges, social enterprises play a crucial role in transforming the economic landscape of countries with substantial young populations.

Social enterprises often focus on creating job opportunities and providing skills training, which is vital in countries with high youth unemployment. This not only aids poverty alleviation, but also stimulates local economies. Considering that the global youth unemployment rate was 13.6 percent in 2019, according to the International Labour Organization (ILO), the role of social enterprises in job creation is crucial (ILO, 2022). For example, in countries like Kenya and India, youth-led social enterprises have been instrumental not only in creating jobs, but also in providing relevant skills and experience to the youth.

Social entrepreneurship offers a path toward creating new jobs and economic opportunities within these regions. For instance, a study by the British Council found that social enterprises in India have generated over 2 million jobs. Another example study conducted by the Global Entrepreneurship Research Association (GERA) found that social enterprises in various developing countries employ a significant portion of the young workforce, thereby addressing issues of unemployment.

### Impact of social entrepreneurship on skill development

Social entrepreneurship provides youth with opportunities to develop leadership skills, problem solving, financial literacy, to think creatively and to engage actively in societal issues. It encourages them to take an active role in shaping the future of their communities. Encouraging entrepreneurship can be a key strategy to harness the potential of the youth, along with providing support in terms of finance, mentorship and infrastructure. Each category is represented by the percentage of improvement observed, demonstrating the significant positive changes these workshops have fostered in children aged 7–13 years. This graphical representation effectively highlights SosyalBen's role in enhancing essential personal and social development skills through its diverse range of activities. The methodology behind measuring this impact involves a combination of qualitative and quantitative research methods, including pre- and post-workshop assessments, surveys and interviews. These tools are designed to accurately evaluate changes in cognitive and social skills among the participants. By analyzing data before and after workshops, alongside qualitatively demonstrates the effectiveness of its programs in contributing to the holistic development of the children it serves.

Furthermore, by exposing children to new opportunities and ideas, SosyalBen plays a critical role in broadening their horizons and aspirations. This exposure can inspire them to pursue higher education and careers they may not have considered possible, directly influencing their future employment prospects and potential to contribute to their communities. The children and communities served by SosyalBen gain the skills, confidence and aspirations needed to pursue educational and employment opportunities, contributing to a better skilled and more resilient workforce.

## Policy recommendations for supporting social entrepreneurship

To maximize the transformative potential of social entrepreneurship in countries with youthful populations, policymakers, practitioners and stakeholders alike should consider implementing supportive frameworks, financial incentives and capacity-building programs.

Amid the formidable challenge of youth unemployment and the promising potential of social entrepreneurship in addressing societal issues, the imperative for governments to developing countries to establish enabling environments for social enterprises becomes increasingly apparent. Recognizing the multifaceted benefits of social entrepreneurship, including its capacity to not only generate economic opportunities, but to also nurture essential skills and community engagement among the youth, underscores the importance of comprehensive policy frameworks. This transition sets the stage for a detailed exploration of policy recommendations aimed at harnessing social entrepreneurship in order to address youth unemployment and facilitate skills development in developing countries

Supportive ecosystems for social entrepreneurship in developing countries can take multiple forms.

a. Implementing legal frameworks that specifically recognize and define social enterprises. This recognition can facilitate tailored support and legitimacy, encouraging more youth to engage in social entrepreneurship. For instance, in Colombia, the "Empresa de Oportunidades" law provides legal recognition and support for social enterprises (Villamizar, 2023).

- b. Policies should facilitate access to capital through microfinance initiatives, social impact bonds and government grants. Public-private partnerships can also play a key role in financing social ventures. So, too, can establishing and promoting microfinance institutions and credit facilities targeted at young social entrepreneurs with low-interest rates and manageable repayment terms in order to enhance access to finance and credit facilities, as is the case with the Grameen Bank in Bangladesh (Boston Consulting Group, 2018).
- c. Creating platforms, opportunities and providing market access for social enterprises facilitating market access and networking opportunities for social enterprises to access markets more easily, including government procurement programs that prioritize social enterprise products and services. In addition, developing partnerships between social enterprises and vocational training centers in order to ensure skills being taught are aligned with market needs.
- d. Integrating entrepreneurship into school and high school curricula in order to build business acumen and foster an entrepreneurial mindset from a young age. For instance, it is important to establish entrepreneurship training programs that equip young individuals with both business and social impact skills such as in Nepal, where the King's College introduced courses on social entrepreneurship, fostering youth-led initiatives (Prajapati, 2019). Another example is that of the YouthStart Entrepreneurship Program in Africa (ILO, 2014).

Amid the critical challenge of youth unemployment and the promising potential of social entrepreneurship as a solution, the example of the SosyalBen Foundation vividly illustrates the necessity for supportive ecosystems. This social enterprise, rooted in the mission of empowering disadvantaged children through educational and social projects, showcases the tangible benefits of integrating social entrepreneurship within educational systems and fostering collaborations across a network of stakeholders, including enterprises, educational providers and governmental bodies.

However, SosyalBen's journey provides insightful lessons on navigating challenges within this context. Faced with obstacles such as securing sustainable funding and adapting to regulatory environments, SosyalBen has innovatively tackled these issues through initiatives like the SosyalBen Academy and SosyalBen Store. These solutions not only created alternative revenue streams, but also reinforced the Foundation's commitment to education and empowerment. By launching the SosyalBen Academy, the organization developed a platform for skills development and training in social entrepreneurship, addressing both funding needs and its educational mission. The SosyalBen Store, offering merchandise related to the organization's brand, further contributed to financial sustainability while increasing public awareness. These strategies demonstrate how social enterprises can creatively overcome challenges by aligning business models with mission-driven goals, thus providing a blueprint for policymakers to support similar initiatives. Encouraging the development of enabling policies that facilitate such entrepreneurial creativity and resilience is crucial in leveraging the power of social entrepreneurship to tackle youth unemployment and enhance skill development.

SosyalBen's journey from an educational concept to a flourishing social enterprise underscores the vital role of educational integration. SosyalBen highlights how educational institutions can serve as incubators for social innovation, blending theoretical knowledge with practical community service. This integration within academic curricula is pivotal, preparing students for real-world challenges by nurturing essential skills such as critical thinking, empathy and leadership.

Furthermore, SosyalBen's development has been significantly supported by partnerships with businesses and governmental organizations, which have provided financial support, mentorship and market access. By investing in these areas, governments can harness the potential of their young populations, fostering economic growth and social development.
