THE HAGUE AGREEMENT CONCERNING THE INTERNATIONAL DEPOSIT OF INDUSTRIAL DESIGNS

Publication of the *International Designs Bulletin* on CD-ROM; Reduction of the Publication Fee

- 1. With effect from March 1999, the present (paper) publication of the *International Designs Bulletin* will be replaced by
- (i) a monthly publication on CD-ROM which will include all the bibliographic data and reproductions of the designs contained in the new deposits registered under the 1960 Act, on a cumulative basis (see below); and
- (ii) a monthly publication on paper which will contain all the data contained in the present publication with the exception of the reproductions of the designs registered under the 1960 Act, that is: the bibliographic data of deposits registered under the 1960 and 1934 Acts, and the information on renewals, prolongations, changes of ownership, changes of owner's name or address, appointments of representatives, renunciations of such appointments, renunciations of deposits and refusals, and also corrections made to the International Register.
- 2. The great advantage for users of the publication on CD-ROM (apart from the compactness of the publication) will be the ease with which they can search for deposits that interest them according to various criteria or combinations of criteria, such as deposit number, deposit date, designated countries, Locarno Classification and name of depositor. Apart from that, because a compact disc will contain about nine months' worth of registrations, it is planned that each disc will accumulate data from the preceding months until it is "full." As a result, it will be possible to carry out a search through a year of international registrations using just two discs. This will make it unnecessary to have a table of owners for new deposits governed by the 1960 Act.
- 3. Since the *total* cost of the publication on paper (*without* the reproductions) and of the production of the CD-ROM (which, alone, will include the reproductions) will be lower than the current cost of the Bulletin, the publication fee will, with effect from January 1, 1999, be reduced by 20%.

- 4. The establishment of an electronic publication of the *International Designs Bulletin* has made it necessary to amend the Regulations under the Hague Agreement, in particular in respect of those provisions that relate to the reproductions of industrial designs. Accordingly, during its seventeenth session (September 7 to 15, 1998), the Assembly of the Hague Union adopted, with effect from January 1, 1999, amendments to Rules 1.1(xxi), 3.1(c), 5.1(c)(ii), 9.2(b), 12.1, 14.2(c)(viii), 16.1(ix), 17.1(b)(ix) and 2(a)(ii), and 22(1)(c) of the Regulations and to the Schedule of Fees annexed to the Regulations.
- 5. The above-mentioned amendments have also entailed, after consultation with interested Offices, changes to Sections 101, 302, 303, 306, 401, 402, 404, 405, 601, 602 and 603 of the Administrative Instructions. These changes will also become effective on January 1, 1999.
- 6. The present notice provides an explanation of the above-mentioned changes. The amended text of the Rules and Administrative Instructions concerned appear in the Annex.

Amendments to the Regulations

Definition of "Bulletin"

7. The amendment to Rule 1 relates to the definition of the word "Bulletin" which specifies that the periodical publication of the relevant data of international deposits may take more than one form. In fact, the "Bulletin" will be a combination of the new CD-ROM and the paper publication reduced to bibliographic data.

Number of required copies of reproductions and specimens of the deposited designs

- 8. The amendment of Rule 12.1(a) consists of reducing from two to one the number of copies of reproductions or samples required for the deposited designs. Indeed:
- for designs deposited under the 1960 Act, given the new publication mode for reproductions (on CD-ROM), the International Bureau will no longer require a second set, for the printer, of the photographs or other graphic representations that are filed (in addition to the set of reproductions affixed to the application for registration). From January 1, 1999, the reproductions intended for publication on CD-ROM will be scanned, using the single copies accompanying the application;
- for designs deposited under the 1934 Act, a single photograph or other graphic representation, or a single sample, is sufficient as any subsequent communication with the competent authorities of the member States referred to in Article 14 of the 1934 Act is made by supplying photographs of the representations or samples kept by the International Bureau.

9. The reduction from two to one of the number of copies of reproductions and samples required has entailed the deletion of the words "except in the case where the photographs, other graphic representations, samples or models were furnished in one copy only" in paragraph 2(c)(viii) of Rule 14.

Transparencies

10. Subparagraphs 1(b), (c) and (d) of Rule 12 and Rules 3.1(c), 5.1(c)(ii), 9.2(b) and 16.1(ix) have been amended so as to delete any mention of "transparencies" since these latter no longer serve any useful purpose in the context of the international procedure.

Numbering of reproductions

11. Rule 9, as it stood before amendment, provided that each design included in a multiple deposit should be identified by a different number appearing "on" the reproductions. The amendment to that Rule consists of deleting that requirement, since a single copy of the reproductions (instead of the two currently required) will accompany the application and scanning will be effected from that copy. As a result, the numbering of industrial designs contained in a multiple deposit can no longer appear on the representations themselves but will have to be shown alongside those representations, as indicated in the Administrative Instructions (see change to Section 402 in paragraph 31, below).

Starting point of the time limit for refusal

12. Since the new CD-ROM will be cumulative, a given deposit will be repeated for several months on the same CD-ROM. Rules 17 and 22 have been amended to specify that the publication to which they refer, which initiates the six-month time limit for refusal, is the *first* publication of the deposit or of the correction concerned.

Amendments to the Schedule of Fees

- 13. The new mode of publication for international designs results in substantial savings which have been be passed on to the depositors as a corresponding reduction in the publication fee (by 20%), thus requiring modification of the Schedule of Fees. The new amounts of the publication fees are the following:
- 33 Swiss francs instead of 41 Swiss francs for each set of four standard spaces for publication in black and white; and
- 264 Swiss francs instead of 330 Swiss francs for each set of four standard spaces for publication in color.

Amendments to the Administrative Instructions

- 14. The amendments to the Administrative Instructions affect those Sections which concern the *International Designs Bulletin*, those which relate to the International Register and the file of an international deposit and those which bear on the presentation of photographs and other graphic representations. Moreover, Section 102 (and consequentially Annex B of the Administrative Instructions) has been completed in order to take account of the amendment to Rule 19 which was adopted by the Hague Union Assembly during its session of September 1997. This amendment made obligatory the use of a model form for the presentations of a request to record a change of ownership.
- I. AMENDMENTS CONCERNING THE INSTRUCTIONS RELATING TO THE *INTERNATIONAL DESIGNS BULLETIN* (Sections 101, 306, 601, 602 and 603)

Sections 101, 601 and 602(b)

15. Amendments concerning these Sections result from the fact that the *International Designs Bulletin* will be published not only on paper but also in electronic form (on CD-ROM). It should be noted that Section 101 (which follows word for word the definition of the Bulletin contained in Rule 1.1(xxi) as amended with effect from January 1, 1999), permits the introduction of other forms of publication.

Section 306(a)

16. The change of this Section consists of deleting the requirement to allocate the numbers of international deposits published in a given Bulletin in the chronological order of their date of deposit. Such a system, facilitating the retrieval of an international deposit in a given Bulletin by using either its international registration number or its date of deposit would have lost its *raison d'être* in the framework of a publication on CD-ROM, which will contain indexes allowing the retrieval of an international deposit according to several criteria (including its date of deposit). From January 1, 1999, the numbers of international deposits will be allocated in the order of their date of recording in the International Register.

Section 602(a)

17. The publication of the Bulletin on CD-ROM will concern only new deposits governed exclusively or partially by the 1960 Act (bibliographic data and reproductions of the designs). The bibliographic data relating to these deposits as well as all other data which must be published (in particular data relating to deposits governed exclusively by the 1934 Act) will continue to be published on paper. The amendment to Section 602(a) makes clear that the Bulletin may take several forms, that the medium used for the publication may differ according to which Act is applicable and that, although several media may exist, the publication may be effected on only one of these media (for example, the reproduction of international designs will be published only on CD-ROM while, at least for the time being, the bibliographic data of deposits governed exclusively by the 1934 Act will be published only on paper).

- 18. The amendments to this Section do not appear to require explanation. It should be noted however that, for the time being, it is not intended to increase the subscription price of the Bulletin.
- II. AMENDMENTS CONCERNING THE INSTRUCTIONS RELATING TO THE INTERNATIONAL REGISTER AND TO THE FILE OF AN INTERNATIONAL DEPOSIT

(Sections 302 and 303)

Section 302

- 19. At present, the file of each international deposit comprises two parts. The first part of the files, containing reprints of all the publications made in respect of international deposits, together constitute the International Register. The second part of each file contains the application and all other items which relate to that application or to the international deposit.
- 20. Independently of the fact that from February 28, 1999, (the date on which the final issue of the Bulletin in its present form will be published) any "reprints" of the publication on paper will contain only the bibliographic data (and not the reproductions), there was no longer any reason to continue to keep the International Register in paper form, given the information technology available to the International Designs Registry. The amendments to this Section thus consist of:
- defining the content of the International Register, not by reference to a part of the file of an international deposit, but as the collection of data and reproductions that the International Bureau is required to keep in accordance with Rule 3.1(a) to (c) of the Regulations (paragraph (a), first sentence);
- providing for the keeping of the International Register in electronic form for recordings published after February 28, 1999, (the Register continuing to be constituted, as far as recordings published up to that date are concerned, by the reprints contained in the files) (paragraph (b), second sentence);
- limiting, in future, the content of the file of each international deposit to that which at present constitutes the second part (paragraph (b));
- maintaining in the file, for the past, the reprints of the publications of all recordings made before March 1, 1999, (paragraph (c));
- deleting the second sentence of paragraph (b), which no longer serves any purpose once the International Register is kept in electronic form (while the Register was constituted by the first part of the file, containing the reprints of the publication, the only way of recording a deposit whose publication was deferred while awaiting publication was to put the application of the deposit in question in the said part of the file).

- 21. The amendments to paragraph (a) do not appear to require explanation.
- 22. The words "that constitute the second part of the file referred to in Section 302(b)" have been omitted from paragraph (b) as a consequence of the discontinuance of the two-part file of an international deposit.
- III. AMENDMENTS CONCERNING THE INSTRUCTIONS RELATING TO PHOTOGRAPHS OR OTHER GRAPHIC REPRESENTATIONS (Sections 401, 402, 404 and 405)

Section 401

23. This Section has been divided into five new paragraphs ((a) to (e)).

Paragraph (a)

24. The words contained in paragraph (a) already appeared in this Section. Their relocation in the text of the Section makes clear that this provision applies to all international deposits, not just those which are governed exclusively or partially by the 1960 Act.

Paragraphs (b) and (c)

- 25. The amendments to paragraph (b) result from the reduction from two to one of the number of copies required by Rule 12 as amended with effect from January 1, 1999.
- 26. This paragraph allows depositors to accompany their applications not only by reproductions pasted on the standard spaces provided on the application form but also by reproductions directly printed onto one side only of a separate sheet of A4 paper not showing the grid of standard spaces, without prejudice, under paragraph (c), to the method of calculating the publication fee or to the other requirements relating to the presentation, the numbering or the quality of the reproductions. In practice, in order to calculate the publication fee where the reproductions are directly printed on a separate sheet, the International Bureau will superimpose on the sheets bearing the reproductions a transparent grid identical to that appearing in the application form.
- 27. This amendment aims to meet the wishes of depositors who are in a position to print their designs directly by electronic means. It frees them from having to carry out the inconvenient task of pasting (particularly where the number of reproductions is high).

Paragraph (d)

- 28. At present, the printer of the Bulletin uses the second set of reproductions which accompanies the application. As from January 1, 1999, the reproductions intended for publication on CD-ROM will be scanned, using the single copies pasted on the application form or printed on a separate sheet.
- 29. The scanning and indexing of a reproduction entails a frame which does not contain any other reproduction or part thereof. The term "right-angled quadrilateral" used in paragraph (d) covers a square or a rectangle.
- 30. The scanning also requiring a careful presentation of the reproductions, it has been added that the reproductions must not be "marked in any way."

Section 402

31. Given that a single copy of the reproductions (in place of the two required at present) will accompany the application and that the scanning will be effected using this single copy, this Section has been amended so as to provide that the numbering appears in the margin and not on the reproductions themselves.

Section 404

32. This Section has been amended so as to provide that *all* the edges of photographs or other graphic reproductions pasted on the application form be cut at right angles (so that the grid of standard spaces does not appear inside the quadrilateral referred to in Section 401(d)).

Section 405

- 33. This Section has been amended so as to specify that the paper on which the graphic representations appear be "opaque" so that, if it is pasted on the application form, the grid of standard spaces is not visible.
- 34. The amendment also consists of providing that the paper on which the graphic representations appear have all its edges cut at right angles (see paragraph 32, above). It should be noted that this condition will necessarily be fulfilled in the case of graphic representations printed on a separate sheet, since Section 401(b) provides that this sheet be of A4 size.

ANNEX

AMENDMENTS TO THE REGULATIONS AND ADMINISTRATIVE INSTRUCTIONS

REGULATIONS

Rule 1

Abbreviated Expressions

1.1 Abbreviated Expressions

For the purposes of these Regulations:

[...]

(xxi) "Bulletin" means the periodical publication containing the data relating to international deposits whatever the medium used for that publication.

Rule 3

The International Register

3.1 Contents of the International Register; Keeping of the International Register

[...]

(c) In the case of international deposits which are governed exclusively or partly by the 1960 Act, the International Register shall contain, in addition to the indications referred to in paragraph (a), the reproduction of photographs or other graphic representations filed.

[...]

Rule 5

Mandatory Contents of the Application

5.1 *Mandatory Contents of the Application*

[...]

(c) In the case of international deposits governed exclusively or partly by the 1960 Act, the application shall contain, in addition to the indications referred to in paragraph (a):

(ii) an indication of the documents, photographs or other graphic representations accompanying the application;

[...]

Rule 9

Multiple deposit

[...]

9.2 Other Rules Applicable to Multiple Deposits

[...]

(b) Each design included in a multiple deposit and each sample or model which may accompany the application shall be identified by a different number. Numbering shall be applied to the photographs or other graphic representations in accordance with the Administrative Instructions.

Rule 12

Reproduction, Samples and Models of the Designs or Articles

12.1 Reproduction, Samples and Models

- (a) In the case of international deposits governed exclusively by the 1934 Act, the application shall be accompanied by one photograph or other graphic representation or one sample of each design or of each article in which it is intended to incorporate the designs.
- (b) In the case of international deposits which are governed exclusively or partly by the 1960 Act, the application shall be accompanied, for each design or for each article in which it is intended to incorporate the designs, by one photograph or other graphic representation, in color if the depositor requests publication in color or, failing that, in black and white, presented in accordance with the provisions of the Administrative Instructions. Additionally, the application may be accompanied by samples or models of the article or articles. The dimensions of the representation of each design or article shown in the photographs or other graphic representations accompanying the application shall be those in which the depositor wishes the design to be published, provided that one of those dimensions shall be not less than 3cm. The dimensions of the representations of the articles shall not be more than 16cm x 16cm.

- (c) Photographs or graphic representations shall be of a quality permitting all the details of the articles shown in them to be clearly distinguished and admitting of reproduction in accordance with the provisions of the Administrative Instructions.
- (d) The same article may be represented from different angles; reproductions of the article viewed from different angles may be shown on the same photograph or graphic representation or on separate photographs or graphic representations.
- (e) The photographs or other graphic representations or the samples or models relating to one and the same deposit shall be contained in a single envelope or packet. None of the dimensions of any envelope or packet, including packing, shall exceed 30cm and the weight of any such envelope or packet and its packing shall not exceed 4kg. Perishable articles or articles which are dangerous to store shall not be accepted for deposit.

Rule 14

Recording or Declining of the International Deposit

[...]

14.2 Defective International Deposits

[...]

(c) The international deposit shall bear the date on which the correction of the defect was received by the International Bureau where the defect was one of the following:

[...]

(viii) the provisions of Rule 12.1(a) or of Rule 12.1(b), first sentence, were not complied with;

Rule 16

Publication of the International Deposit

16.1 Contents of the Publication of the International Deposit

The publication of any international deposit shall contain:

[...]

(ix) where the international deposit is governed exclusively or partly by the 1960 Act, the reproduction of the photographs or other graphic representations filed;

[...]

Rule 17

Refusals

17.1 Form and Contents of Notifications of Refusal and of Withdrawal of Refusal

[...]

(b) The notification of refusal of protection shall indicate:

[...]

(ix) the date on which the national or regional Office which pronounced the refusal received the issue of the Bulletin in which the international deposit was published for the first time;

[...]

- 17.2 Recording, Transmittal and Publication of Refusal and Withdrawal of Refusal
 - (a) The refusal shall not be recorded in the International Register:

[...]

(ii) if the date referred to in Rule 17.1(b)(ix) has not been indicated, unless the notification of refusal was received by the International Bureau within six months after the publication date of the issue of the Bulletin in which the international deposit was published for the first time;

Rule 22

Corrections

22.1 Corrections

[...]

(c) Where a refusal pronounced by a national or regional Office relates to a corrected element, Rule 17 shall apply *mutatis mutandis*. The date referred to in Rule 17.1(b)(ix) shall be considered by the International Bureau to be the date of receipt by the national or regional Office of the issue of the Bulletin in which the correction was published for the first time.

Schedule of fees

Amounts (Swiss francs)

I. Fees payable if the deposit is governed exclusively or partly by the 1960 Act (deposits published under the 1960 Act)

2. International publication fee (Rule 13.2(a)(ii))

2.1 For publication in black and white, per set of four standard spaces*

A standard space is 4cm x 4cm; the fee is calculated on the basis of the number of spaces or sets of spaces completely or partly occupied by the representation of the article or articles in which it is intended to incorporate the designs included in the deposit. One single space cannot include the representation, in whole or in part, of several articles or the representation, in whole or in part, of one single article viewed from different angles.

ADMINISTRATIVE INSTRUCTIONS

Section 101

Abbreviated Expressions

For the purposes of these Administrative Instructions:

(xii) "Bulletin" means the periodical publication containing the data relating to international deposits, whatever the medium used for that publication;

Section 102

Use of the Forms

- (a) The forms reproduced in Annex B of these Administrative Instructions (Forms DM/1(a), DM/1(b), DM/3, DM/4(a), DM/4(b) and DM/25) are part of the Administrative Instructions.
- (b) The application shall be made on Form DM/1(a) if the depositor is a national of a State bound by the 1960 Act and on Form DM/1(b) if the depositor is a national of a State bound exclusively by the 1934 Act and not by the 1960 Act.
- (c) The unofficial notice of expiration referred to in Rule 23.1 and the reminder referred to in Rule 24.1 shall be established on Forms DM/4(a) and DM/4(b), respectively.
- (d) The use is recommended of Form DM/3 for notifications of refusal of protection, the reverse side of Form DM/4(b) for the demand for prolongation referred to in Rule 23.2, and the reverse side of Form DM/4(a) for the provision of the indications referred to in Rule 24.2(c) that have to accompany the payment of the renewal fees.
- (e) The request for recording a change in ownership referred to in Rule 19.1 shall be made on form DM/25.

Section 302

Form of the International Register and Procedure for Making Recordings Therein; File of an International Deposit

(a) The International Register shall consist, for each international deposit, of all the data and the reproductions referred to in paragraphs (a) to (c) of Rule 3.1. The International Register shall be kept, in the case of recordings published before March 1, 1999, in the form of reprints of all publications made with respect to the international deposits concerned and, in the case of recordings published after February 28, 1999, in the form of an electronic database.

- (b) A file shall be established for each international deposit containing the application and any request, communication, correspondence or other document concerning the application or the international deposit.
- (c) For international deposits in respect of which the recording was published before March 1, 1999, the file shall also contain the reprints referred to in paragraph (a) of the present Section. The reprints shall be numbered consecutively in the order of their recording date. A summary sheet shall be established in the same order and included in the file.
- (d) A filing system shall be established so that each file may be easily consulted and updated without being removed from the place where it is located.

Conservation of the International Register and of the Files of International Deposits

- (a) The International Bureau shall conserve indefinitely the International Register. The reprints referred to in Section 302(a) may be conserved on any suitable medium, including in electronic form.
- (b) The International Bureau shall conserve, during the total duration of the deposit and for five years thereafter, the application and any requests, demands, communications, correspondence or other documents concerning the application or the international deposit.

Section 306

International Deposit Numbers

- (a) The International Bureau shall assign to each international deposit which is governed exclusively or partly by the 1960 Act an international deposit number consisting of the letters DM, an oblique stroke and a six-digit number (e.g., "DM/000705").
- (b) For as long as publication of an international deposit is deferred, that deposit shall have a provisional number consisting of the letters DMA, an oblique stroke and a six-digit number (e.g., "DMA/000025").
- (c) The International Bureau shall assign to every international deposit governed exclusively by the 1934 Act a deposit number according to the numbering used since the entry into force of the Hague Agreement.

Presentation of Reproductions

- (a) One and the same deposit may comprise both photographs and graphic representations.
- (b) Where the international deposit is governed exclusively or partly by the 1960 Act, each of the photographs or other graphic representations accompanying the application shall be either pasted on the standard spaces provided on the application form or printed directly onto one side only of a separate sheet of A4 paper which is white, opaque and does not bear the grid of standard spaces.
- (c) The method of calculating the publication fee referred to in the Schedule of Fees and, unless provided to the contrary, the requirements of Sections 401 to 405 apply equally to reproductions which are pasted on the standard spaces and to reproductions which are printed on separate sheets. In particular, the photographs or other graphic representations must lie within a frame whose dimensions must not exceed 16x24 centimeters.
- (d) Each reproduction must fall within a right-angled quadrilateral not containing any other reproduction or part of another reproduction. The photographs or other graphic representations shall not be folded or stapled or marked in any way.
- (e) Where a design (in two dimensions) is intended to be applied to two or more articles that form a whole (e.g., a dinner service), the deposit may comprise only one of the articles forming the whole (e.g., a plate) that will be shown in the photographs or other graphic representations accompanying the application.

Section 402

Numbering of Reproductions

The numbering stipulated for multiple deposits shall appear in the margin of the photographs or other graphic representations, outside the standard spaces provided on the application form or outside the frame within which the reproductions are printed. When the same article is represented from different angles, the numbering shall consist of two separate figures separated by a dot (e.g. 1.1, 1.2, 1.3, etc. for the first article, 2.1, 2.2, 2.3, etc. for the second article and so on).

Section 404

Requirements for Photographs

(a) The photographs supplied must be of professional standard. The articles must be shown against a neutral plain background. Photographs retouched with ink or correcting fluid are not allowed.

- (b) Reproductions of photographs that meet the conditions set forth in paragraph (a) and have been produced by means of electronic processes shall be allowed if they are themselves of professional standard and not retouched.
- (c) Photographs or reproductions of photographs which are pasted on the standard spaces provided on the application form shall have all the edges cut at right angles.

Requirements for Graphic Representations

Graphic representations must be either originals of professional standard produced with drawing instruments or by electronic means on good quality white, opaque paper, all of whose edges are cut at right angles, or prints or photocopies made from such originals and having the same quality. The lines must be even and boldly drawn. The article represented should preferably be in perspective; it may comprise shading and hatching to provide relief; it may be shown against a background, provided that it is neutral and plain.

The following shall not be accepted:

- (i) technical drawings showing articles in section or in plan, particularly with axes and dimensions;
 - (ii) explanatory texts or wording shown on or adjacent to the articles.

Section 601

Matters to be Published

- (a) In addition to the matters to be published under Rule 29.1(a), the Bulletin shall contain:
 - (i) in each issue, a list of the States party to the Agreement;
- (ii) once a year, statistics relating to international deposits, prolongations and renewals effected during the previous year;
- (iii) once a year, one or more indexes permitting the retrieval of the numbers of the international deposits in respect of which a publication has been made in the course of the previous year;
- (iv) once a year, where appropriate, a table of contents showing the articles and studies referred to in paragraph (b) below which were published in the course of the previous year.

- (b) The Bulletin may also contain:
 - (i) articles and studies concerning the Agreement or the Regulations;
 - (ii) a part reserved for paid advertising connected with intellectual property.

Publication of the International Deposit in Accordance With the Applicable Act

- (a) The publication of the Bulletin shall be effected on any suitable medium; this medium may differ according to which Act governs the international deposits. The use of a single medium shall be considered fully sufficient for the purposes of any prescribed publication.
- (b) International deposits governed exclusively or partly by the 1960 Act and international deposits governed exclusively by the 1934 Act shall be published separately.
- (c) In the publications relating to international deposits governed exclusively or partly by the 1960 Act, the States to which the deposits extend their effects shall be shown in two groups:
 - I. States in respect of which the 1960 Act applies;
 - II. States in respect of which the 1934 Act applies.

Section 603

Subscription and Other Forms of Sale

- (a) The subscription prices of the Bulletin, which shall be annual starting from the first issue of the year, shall be as follows:
- (i) full subscription (CD-ROM edition and paper edition): 460 Swiss francs a year;
 - (ii) paper edition only: 115 Swiss francs a year.
- (b) The Bulletin may also be sold in the form of annual collections starting from the first issue of the year. The prices of annual collections shall be the same as that of the annual subscriptions
- (c) The paper edition of the Bulletin may be sold singly, at a price of 15 Swiss francs per issue.
