

# 2024 WIPO National Intellectual Property Essay Competition Report

IP and Sustainable Agriculture: Combating Food Insecurity in Nigeria

#### October, 2024

# **Competition Overview**

The maiden edition of the WIPO National Intellectual Property Essay Competition was launched on April 26, 2020, by the WIPO Nigeria Office (WNO) as part of efforts to support student engagement and research in the field of intellectual property (IP) in Nigeria.

Building on the success of the maiden edition, WNO launched a second and subsequently a third edition of the competition in 2021 and 2023 respectively as part of the office's World IP Day activities in both years.

A fourth edition of the competition was launched this year on April 27, 2024, inviting students of tertiary institutions across Nigeria to submit essays not exceeding 1500 words on the topic "IP and Sustainable Agriculture: Combating Food Insecurity in Nigeria". The objective was to provide an opportunity for students to research and learn more about the field of IP, as well as contribute to policy development in this area by exploring suggestions or ideas that could help Nigeria in achieving the Sustainable Development Goal (SDG) 2 – Zero Hunger.

By the final submission deadline of June 14, 2024 the WNO had received a total of 256 entries.<sup>1</sup> These entries emerged from students representing a total of 29 tertiary institutions across Nigeria and 19 distinct disciplines, including undergraduate and graduate students of universities as well as the Nigerian Law School.

### **Assessment of Entries**

## Preliminary Review

Two main tasks were completed by the planning committee as part of the preliminary review process.

- a. First, all entries were completely anonymized for the assessment process and assigned unique competition identification numbers (WNO 001 – WNO 256). These serial competition identification numbers were assigned in accordance with the submission timestamp of each entry.
- b. Second, an initial preliminary review of the 256 entries was carried out by the planning committee, focused on form and aimed at ensuring compliance of submissions received with the stated rules of the competition. This review resulted in the disqualification of 18 entries to the competition. A total of <u>238</u> valid entries were consequently maintained for transmission to the panel of judges for formal assessment. The studentship of contestants was verified through their student identity cards or letters from relevant authorities in the institution.

# Judges' Assessment

The assessment by the Panel of Judges was based on a pre-determined set of criteria which was maintained through the competition's three stages of assessment. In keeping with the competition's objectives, the equally weighted assessment criteria, was as follows:

- Author's imagination and originality (20)
- Relevance of essay to broader national, regional, and/or international developments (20)
- Author's demonstrated understanding of the field of intellectual property, and ability to link concepts and/or issues associated with IP, to ideas or suggestions expressed in essay (20)
- Grammatical accuracy, clarity of expression, flow, and thought, integrity of structural layout (20)
- Practicability and relevance of policy suggestions and/or pathways to Nigeria (20)

As noted above, a three-stage process was adopted in assessing the entries:

## Stage one

For the first round of assessment, 18 out of the 20 judges were each assigned 12 serial anonymized entries, while 2 judges were assigned 11 serial anonymized entries. All the judges were tasked with the responsibility of identifying the top 3 entries from the entries received. The top three entries from each judge's first round assessment automatically proceeded to the second stage of the competition. However, three entries, WNO\_041, WNO\_126 and WNO\_235 were discovered to be duplicates and were disqualified.

A total of 57 shortlisted entries therefore proceeded to stage 2 of the assessment process. The 57 shortlisted entries are indicated below:

# Stage Two

For the second assessment round, the judges were placed into five blind-groups² comprising four judges each. Each blind group was assigned 12 entries from the shortlisted 60 entries above. In the assignment of entries to groups, the planning committee ensured that none of the groups was assigned an essay that <u>any</u> of the respective group members had previously assessed; while also ensuring that the entries assigned to each blind group were based on a random combination of the top 3 in the initial judging stage (stage one). Adopting the same criteria from the previous round, the judges were required to assess the 12 entries. Based on an average of the scores assigned to each entry by the four judges in each group, the top four entries of each group were determined. These top four picks of each group emerged as the 20 finalists of the competition. The overall top entry of each respective group however formed the top five essays from the competition and proceeded to stage three of the judging process. This third stage was aimed primarily at ascertaining the winners; overall winner, first and second runners up. The 20 finalists are indicated below:

# Stage three

To ascertain the winner of the competition, the top five entries were reassigned to all 20 judges for a final assessment. Once again, this was based on the same criteria established from the outset. At the end of the third assessment process, using a weighted average of scores allocated to each entry by the participating judges, the Panel of Judges returned an overall winner, a first runner up and a second runner up. The representation of the stage three assessment is indicated below.

#### Ratification of results

A final review and ratification of the results was done by the Panel of Judges via email to confirm the results of the competition. A quorum of 12 judges was set as the benchmark for ratification of the results. 17 of the judges responded to the request for confirmation, which exceeded the quorum and ratified all results of the competition. The winners of the competition are as follows

- 1. Mr. Ikenna Mba, University of Nigeria Overall Winner
- 2. Mr. Chinonso Izundu, University of Port Harcourt First runner up
- 3. Mr. Adekunle Olajide, University of Ilorin Second runner up

It is worth reiterating that the judges concluded their assignments, including their final determinations, without knowing the identities nor affiliations whatsoever of the winners and finalists.

#### **Winners Announcement**

On October 4, 2024 the WNO announced the results at a virtual event attended by the participants of the essay competition and some of the members of the panel of Judges. Mr. Edward Kwakwa, Assistant Director General, Global Challenges and Partnerships Sector, WIPO, delivered the keynote address at the event. Additionally, a detailed breakdown of the competition and assessment processes and timelines were shared by Mr. Oluwatobiloba Moody, Director, WIPO Nigeria Office and Ms. Taiwo Farai, Communications Officer, WIPO Nigeria Office.

The announcement of the 17 finalists was made by Ms. Taiwo Farai while the announcement of the winners was made by Mr. Edward Kwakwa.
