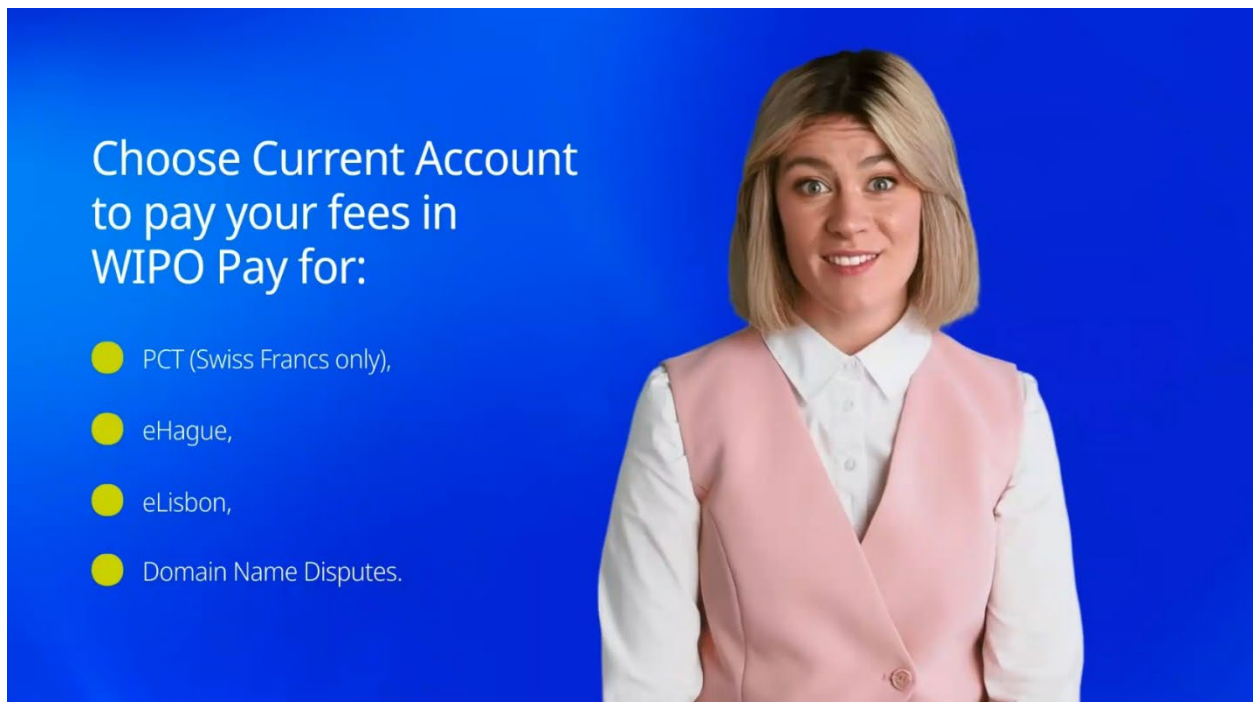


## CURRENT ACCOUNT AT WIPO: PAYING IN WIPO PAY

Hey there! Welcome to our tutorial.

In this video you will learn how to pay with a Current Account at WIPO in WIPO Pay.

WIPO Pay is WIPO's payment application. With WIPO Pay you can pay using your Current Account at WIPO for PCT, eHague, eLisbon, and Domain Name Disputes fees.




Remember to file your application prior to accessing WIPO Pay and to access WIPO Pay always with the same WIPO Account that you used for the filing.

**Before authorizing any payments with a Current Account at WIPO, please make sure that your Current Account has sufficient funds to make the payment.**


**Remember:**

- File your application before accessing WIPO Pay
- Access WIPO Pay with the same WIPO Account you used for filing
- Check your Current Account at WIPO balance

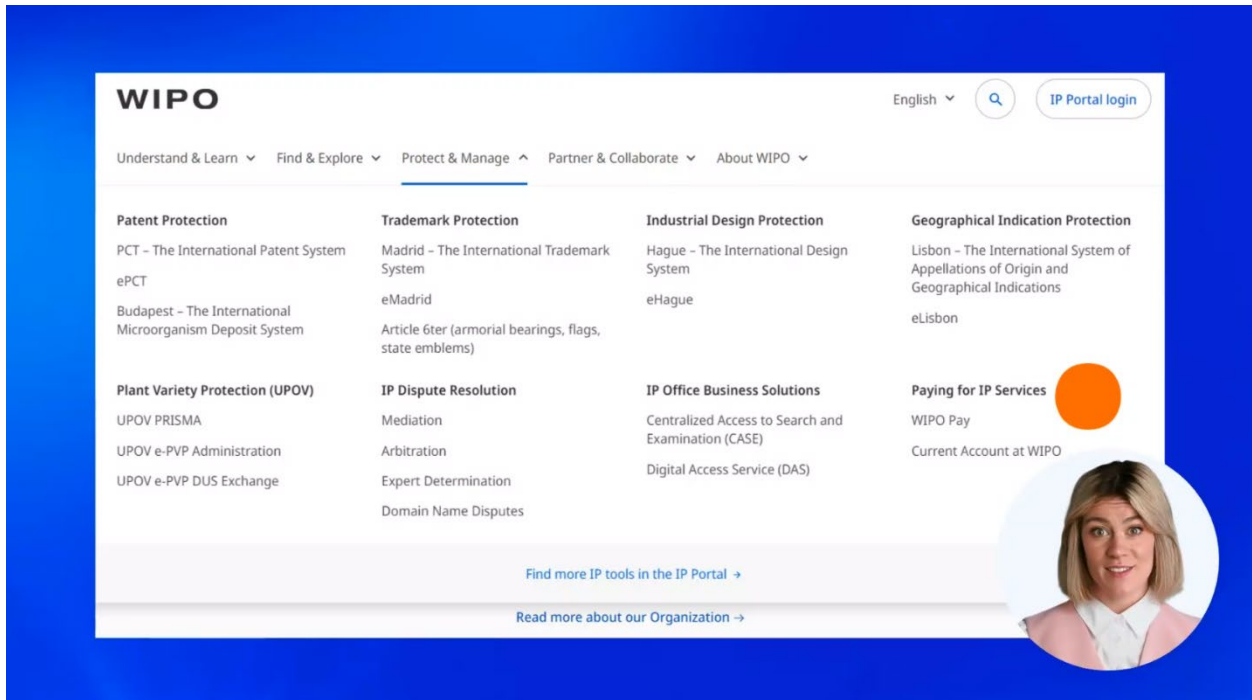


Let's make a payment with a Current Account at WIPO right now!

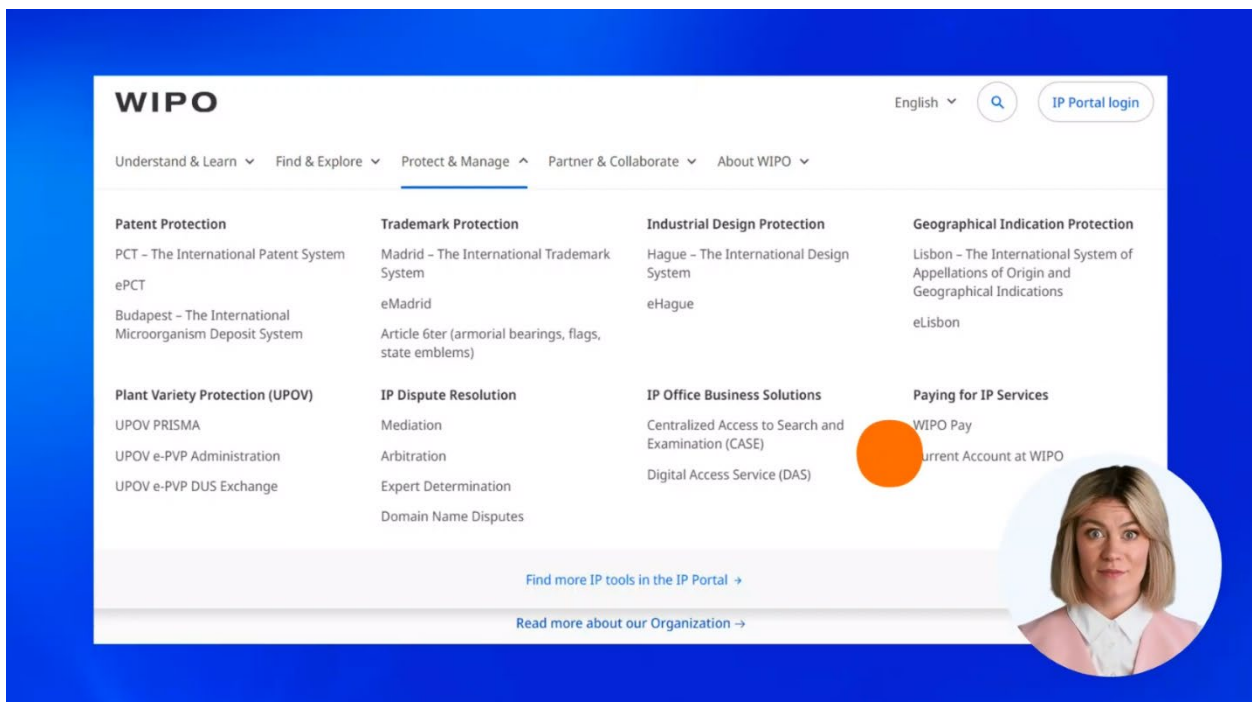
Go to WIPO's official website and click on "Protect and Manage".



A menu will open. Find the menu title "Paying for IP Services".



Click on "WIPO Pay".



Scroll down the page and click on "Access WIPO Pay".

Which payment methods are available in WIPO Pay?

WIPO Pay offers you 6 different payment methods:

- Current Account at WIPO**  
If you **regularly** use WIPO services, then a Current Account at WIPO – managed in Swiss francs – is perfect for you. It's **secure, fast, and free of charge** and provides access to all your payment activity.
- Debit/Credit card**  
Available Credit/Debit cards are: **VISA, MASTERCARD, CHINA UNION PAY, JAPAN CREDIT BUREAU (JCB), DINERS/DISCOVER, and AMEX** (CHF only).
- E-Wallet**  
Available eWallets are: **Apple Pay, Google Pay, Samsung Pay, and Alipay.**
- Paypal**  
Use your own PayPal account.
- Sofort/Klarna**  
Use your own Klarna account. Klarna is available only in some countries. Check the [list of countries](#) where Klarna is available to make sure your country and bank are supported.
- Bank transfer**  
Select bank transfer in case you cannot pay online using other payment methods.


