The Director General of the World Intellectual Property Organization (WIPO) presents his compliments to the Minister for Foreign Affairs and has the honor to refer to Note C. PCT 899, dated February 17, 2003, inviting His Excellency's Government to be represented at the fourth session of the *Working Group on Reform of the Patent Cooperation Treaty (PCT)*, which will be held in Geneva from May 19 to 23, 2003.

The Director General refers to Note C. 6852, dated March 21, 2003 communicating that WIPO will cover the cost of travel by air in economy class and provide a daily subsistence allowance for one delegate designated by His Excellency's Government to participate in the ninth session of the *Standing Committee on the Law of Patents (SCP)*, which will be held in Geneva from May 12 to 16, 2003.

Details of arrangements as set out in the Annex to Note C. 6852 will apply to the additional period of participation.

The Director General would be grateful if His Excellency's Government could communicate to WIPO before April 25, 2003, whether the delegate who is designated to participate in the session of the SCP will stay in Geneva during the week following the session of the SCP to participate in the said session of the Working Group on Reform of the PCT.
