Proposed modifications to Form PCT/IB/306

This circular is addressed to your Office in its capacity as receiving Office (RO), International Searching Authority (ISA), International Preliminary Examining Authority (IPEA) and/or designated and/or elected Office under the Patent Cooperation Treaty (PCT) for the purpose of consultation under PCT Rule 89.2(b). It is also addressed to certain non-governmental organizations.

This circular concerns proposed modifications to Form PCT/IB/306 “Notification of the recording of a change”. Recently, the number of requests from applicants for the recording of changes under Rule 92*bis*, which affect multiple international applications, has grown considerably. These requests usually contain, besides the actual change, a list of international applications affected. Currently, a separate Form PCT/IB/306 is generated for each international application concerned. It is recalled that a copy of Form PCT/IB/306 is also sent to the RO, ISA, IPEA and DOs/EOs, as applicable.

In the future, the International Bureau wishes to provide a more efficient service to applicants who file such requests affecting multiple international applications, and therefore, in order to process such requests more effectively and more quickly, it is proposed that a single Form PCT/IB/306 would be generated in such cases with a list attached of all international applications concerned. That “continuation sheet” would contain, for each international application affected, the applicant’s or agent’s file reference (if available), the international application number and the international filing date. The Form itself would, in respect of these bibliographical data elements, refer to the “continuation sheet” of the Form.
