Sir,

In accordance with Rule 89.2(a) of the Regulations under the Patent Cooperation Treaty (PCT), modifications to the Administrative Instructions under the PCT (Als) and certain PCT forms relating to the Receiving Office (RO), the International Bureau (IB) and the International Preliminary Examining Authority (IPEA) are hereby promulgated with effect from September 16, 2012.

This follows consultations under Rule 89.2(b) of the Regulations under the PCT with your Office in its capacity as RO, ISA and IPEA and/or designated/elected Office (DO/EO), and also with certain intergovernmental and non-governmental organizations. The modifications relate to amendments of the PCT Regulations necessitated following the entry into force of certain changes to the patent law of the United States of America which will enter into force on September 16, 2012 and are as proposed in Circular C. PCT 1349, dated July 6, 2012, except where further changes have been made as a result of consultation, as indicated below (editorial and minor drafting changes are not specifically mentioned).

Modifications of the Administrative Instructions under the PCT (Als)

As a result of the consultation, proposed Section 214 has been further modified for the sake of simplification and easier use by applicants.

Modifications of certain forms relating to the RO, the IB and the IPEA

The following forms: PCT/RO/106, PCT/RO/198, PCT/RO/199, PCT/IB/313, PCT/IB/336, PCT/IPEA/401 and PCT/IPEA/404 are modified as proposed in Circular C. PCT 1349.

C. PCT 1351 2.

The PCT request form (PCT/RO/101) is modified as proposed by Circular C. PCT 1349 and as a result of consultation. In particular, as mentioned above in relation to Section 214, the wording of the declaration of inventorship under Rule 4.17(iv) has been further modified; furthermore, additional wording was added in the Notes to the request form in relation to the Digital Access Service (DAS).

Offices which use languages other than English and French are requested to prepare the Forms needed by them, in such other languages, with due regard to the provisions of Section 102 of the Administrative Instructions. The International Bureau encourages Offices to make such translations available to the International Bureau so that they can be accessed by all Offices from the WIPO website.
