The International Bureau of the World Intellectual Property Organization (WIPO) presents its compliments to the Ministry of Foreign Affairs and has the honor to invite comments on the draft revised lists of States meeting the criteria set out in items 5(a) and (b) of the Schedule of Fees annexed to the Regulations under the Patent Cooperation Treaty (PCT).

Items 5(a) and (b) of the Schedule of Fees provide for reductions of certain fees payable under the PCT to applicants who are nationals of and resident in a State included in lists established for the purpose. The lists are updated every five years in accordance with Directives of the Assembly, set out in Annex II to document PCT/A/46/3. The Directives require the Director General to prepare draft revised lists based on the criteria according to the latest figures available two weeks before the opening of the 2024 session of the PCT Assembly and to make those lists available to the PCT Contracting States and States entitled to observer status in the Assembly for comment before the end of that session of the Assembly.

./. Annex I contains the draft revised lists under items 5(a) and (b) of the Schedule of Fees as they would stand with effect from January 1, 2025. Annex II contains tables showing the figures on which the lists are based.

### EXPLANATION OF BASIS OF LISTS

The following tables show provisional information on the eligibility of States for inclusion in the lists for reductions under items 5(a) and 5(b) of the Schedule of Fees that will be established following the end of the fifty-sixth (32<sup>nd</sup> extraordinary) session of the PCT Assembly on July 17, 2024.

In these tables, the “eligible” columns show “Y” (“Yes”) if the State meets the criteria for inclusion in the relevant list when it will be established or “N” (“No”) if the State will not meet the criteria for inclusion in the relevant list when it will be established. The “Pop.” column shows the average population in the period 2018 to 2022 according to the United Nations statistics. The GDP column shows the average per capita gross domestic product values from the United Nations for the period 2013 to 2022 at constant 2005 United States dollar values. The applications by natural person are based on the provisional figures for international applications (IAs) filed in the period 2019-2023, though the “per million” figure is calculated using the 2018-2022 population figures since the 2023 figures are not available.

The latest United Nations figures have been updated from document PCT/WG/17/5 Rev., published on February 8, 2024, that was provided to the seventeenth session of the PCT Working Group, with some changes in the GDP figures. The figures under other parameters are the same as those in that document. The changes in the GDP figures do not affect the outcome of which States are included in the lists compared to those discussed based on the Working Group document.

To be eligible for the reduction under item 5(a), a State must have a GDP of less than 25,000 United States dollars and either the average total applications by natural persons must be less than 50 or else the applications per million persons must be less than 10. To be eligible for the reduction under item 5(b), a State must be listed as being classified by the United Nations as a least developed country when the lists are established.
