1. La présente circulaire est adressée aux offices en leur qualité :

i) d'office récepteur, d'administration chargée de la recherche internationale, d'administration chargée de l'examen préliminaire international ou d'office désigné ou élu en vertu du Traité de coopération en matière de brevets (PCT) en ce qui concerne des propositions de modification des instructions administratives du PCT; et

ii) de membre du Groupe de travail sur les normes et la documentation du Comité permanent des techniques de l'information (SCIT) de l'OMPI en ce qui concerne la norme ST.36 de l'OMPI intitulée "Recommandation relative à l'utilisation du XML dans le traitement de l'information en matière de brevets".

2. La présente circulaire est également adressée aux organisations intergouvernementales intéressées et à certaines organisations non gouvernementales représentant les utilisateurs du système du PCT ou qui sont représentées avec le statut d'observateur aux réunions du SCIT.

3. La présente circulaire porte sur des propositions de modification de la norme concernant le dépôt et le traitement électroniques des demandes internationales selon le Traité de coopération en matière de brevets (PCT) qui, si elles sont adoptées, entraîneront l'apport de modifications dans l'Annexe F des instructions administratives du PCT et de modifications correspondantes dans les éléments communs internationaux de la norme ST.36 de l'OMPI.

DESCRIPTION DES MODIFICATIONS

4. Les modifications qu'il est proposé d'apporter aux DTD et aux éléments communs internationaux sont indiquées dans le dossier de propositions de modification suivant (voir http://www.wipo.int/pct/efiling_standard/fr/pfc_files.htm) :

- PCT/EF/PFC 09/001 (diverses DTD) propositions du Bureau international.
- PCT/EF/PFC 09/002 (DTD relative aux données bibliographiques wo) propositions du Bureau international.

5. Les modifications de la DTD relative à la requête sont liées aux modifications du formulaire de requête selon le PCT qui résulteront des changements apportés aux instructions administratives concernant les listages des séquences, qui seront promulgués sous peu à l'issue de la consultation faisant l'objet de la circulaire C. PCT 1149; les consultations concernant les modifications qu'il est proposé d'apporter au formulaire de requête selon le PCT feront l'objet d'une circulaire PCT distincte. La date d'entrée en vigueur envisagée pour ces modifications est le 1^{er} juillet 2009. Les modifications relatives à la DTD pour les données bibliographiques wo se rapportent à l'amélioration des données bibliographiques du PCT concernant l'état d'avancement du traitement des demandes internationales pour lesquelles une demande de recherche internationale supplémentaire a été reçue.

CONSULTATIONS

6. Les consultations prévues à la règle 89.2 sont menées conformément à la procédure exposée à la section 2.5 de l'annexe F des instructions administratives du PCT. Des consultations préliminaires relatives à l'actualisation des éléments communs internationaux équivalents qui font partie de la norme ST.36 de l'OMPI sont menées simultanément par le même mécanisme.

7. Le Bureau international souhaiterait recevoir tout commentaire sur les propositions figurant dans les dossiers PCT/EF/PFC 09/001 et PCT/EF/PFC 09/002 au plus tard le 31 mars 2009. Les commentaires sont à envoyer de préférence au moyen de la fonction "Envoyer un commentaire" prévue sur le site Internet (voir http://www.wipo.int/efiling_standard/fr/submit_comment.htm), mais ils peuvent aussi être envoyés par courrier postal ou par télécopie +41-22-338 8040. Les commentaires reçus seront annexés au dossier de propositions de modifications correspondant. Des copies imprimées des propositions seront disponibles auprès du Bureau international sur demande. Les demandes de renseignements concernant ces propositions devront être adressées au Bureau international par courrier électronique (mél. : pct.efiling@wipo.int).

SUITE DU PROCESSUS

8. Une fois que le groupe consultatif créé en vertu de la section 2.5 de l'annexe F des instructions administratives du PCT aura formulé ses recommandations, le Bureau international promulguera les modifications voulues des instructions administratives du PCT, accompagnées de renseignements sur l'entrée en vigueur de ces modifications, et lesdites modifications seront soumises à l'Équipe d'experts du SCIT chargée de la norme ST.36 en vue d'une recommandation visant l'adoption des modifications correspondantes à apporter aux éléments communs internationaux dans la norme ST.36 de l'OMPI.
