

WIPO Development Agenda

The WIPO Development Agenda aims to ensure that development considerations form an integral part of WIPO's work. As such, it is a cross-cutting issue which touches upon all sectors of the Organization.

When formally establishing the Development Agenda in October 2007, the WIPO General Assembly adopted a set of 45 recommendations to enhance the development dimension of the Organization's activities. The recommendations are divided into six clusters. In addition to the adoption of the WIPO Development Agenda, Members States also approved a recommendation to establish a Committee on Development and Intellectual Property (CDIP).

Recommendation 10

To assist Member States to develop and improve national intellectual property institutional capacity through further development of infrastructure and other facilities with a view to making national intellectual property institutions more efficient and promote fair balance between intellectual property protection and the public interest. This technical assistance should also be extended to sub-regional and regional organizations dealing with intellectual property.

The pilot project of "Start-Up" National IP Academies is intended to test a new model to help developing countries and LDCs to establish an IP training institution with minimum resources to meet their increasing demand from IP specialists, professionals, government officials and other stakeholders.

Objectives

The National IP Academy will:

- Contribute to sustainable development of human resources at a national level;
- Enhance IP knowledge and update government officials on new emerging issues of IP rights under debate in WIPO;
- Provide a forum for discussion on IP issues and illustrative the importance of IP for capacity building and national development; and
- Offer the opportunity to share relevant experience among officials from the public and private sectors, IP stakeholders and more importantly with IP experts.

WIPO Academy Collaboration

The WIPO Academy will(...):

- Assist (...) developing countries and LDCs Member States to establish IP Academies and the national and institutional capacity by the end of 2011, thereby increasing the availability of training opportunities to more people from public and private sectors;
- Improve the capability to develop and offer more tailor-made training programs to the specific needs of the country; and
- Advise and provide them with training materials in particular, a curriculum which would be tailor made to suit each country, WIPO experts and IP literature.

Implementation Strategy

Execution Structured in Five Phases:

- Preparatory Phase: Situation Paper
- Feasibility Phase: Implementation of Project and Timeframe
- Project Development: development of Curricula, Training of trainers, establishment of IP library, etc
- Project Implementation: Launch of project
- Conclusion of Cooperation: aiming at self-sustainability



Evaluation of the Cooperation

- Reference: Detailed Implementation Plan for the development of the IP Academy, along with timeframe
- Monitoring Reports: For each twelve-month period of cooperation, prepared by ad hoc consultant
- Self-Evaluation Report –at the end of each year after the launch of each "Start-Up" National IP Academy, with a view to validating that the overall objectives have been achieved, suggesting future actions and highlighting best practices





Objectives of this Workshop:

- If accepted by the national authorities, WIPO will assist the participants in the implementation of their projects
