

#### Goals of the Institute:

- Educating, upgrading and post-graduate training of different specialists especially in IP area;
- Train-the-trainer programs;
- Developing and applying new forms of education;
- Conducting studies and researches on IP-related matters at the request of government and business communities;
- Developing international cooperation (study visits, exchange of students, attendance to the conferences and seminars)
- Taking part in developing IP-related legislative acts and programs, as well as conducting scientific expertise of such drafts;
- Rendering to individuals and different entities educationrelated services, such as consultations, making analysis, methodological support etc

- 1. Self training
- 2. Supervisor's surveillance training
- 3. Training-at-work
- 4. Training through experience-exchange with foreign patent offices
- 5. Training in Rospatent's subordinary state educational institute – the Russian State Institute of Intellectual Property
