

2014 Income by Type (in millions of Swiss francs)




WIPO's Mission:

To lead the development of a balanced and effective international intellectual property (IP) system that enables innovation and creativity for the benefit of all



Geographical Diversity





 - <u>a world reference source</u> for IP information





Main Objectives


- 1. Promoting public awareness campaigns on the importance of the industrial property system

Japan Funds-in-Trust - How to operate? How to evaluate?

- **1-year Work plan** (April to March)
- Operated by WIPO in cooperation with Japan
- Result Based Management
 - Set up measurable targets "Performance indicator"
- Performance indicators for this project/workshop are:
- > <u>No. of institutions</u> participating in the project
- <u>% of participants who apply</u> the enhanced knowledge and upgraded skills <u>in their work</u> (70%)
- Solution of participants providing positive feedback on the relevance/usefulness of their work (70%)




Enabling IP Environment Project
