



 - job is wrongly created by system

Electronic Online System

- Integrating Madrid Workflow into the Electronic Online Platform
 - Beneficial to have a single interface for both National and Madrid applications.
 - Enabling examiners and officers to switch between tasks depending on the demand.

Other Key Features – Keeping track of deadlines and ensure jobs are created (i.e. nothing falls through the cracks)

B) Auto-triggering of a ceasing of effect/central attack job when the following criteria are fulfilled:

- 5 years dependency (from IR date)
- Status change in basic mark (from live to non-live status)
- Amendment of basic mark
- Amendment of specification of good/services of basic mark



Other Key Features – Keeping track of deadlines and ensure jobs are created (i.e. nothing falls through the cracks)

C) Auto-triggering subsequent examination job for partial objection when Holders fail to reply

- For partial refusal, if no response is received, those goods/services that are not objected may still proceed to publication stage
 - IP²SG will automatically create subsequent examination jobs
