1989, China acceded to Madrid Agreement


1995, China acceded to Madrid Protocol

- 2016: 3,691,365









Trademark Law and its revisions

- Adoption of Trademark Law in 1982
- Revision in 1993 (service marks)
- Revision in 2001(three-dimensional marks)
- Revision in 2013(sound marks, multi-class application)





Regulations for the Implementation of the Trademark Law

- Promulgation in 2002
- Revision in 2014





Rules for the Implementation of the Madrid System for the International Registration of Marks:

- Promulgation in 1996
- New promulgation in 2003
- Abolished (detailed rules absorbed by the newly revised *Regulations for the Implementation of the Trademark Law*)

- Independent Examination






