CH: we classify this service in class 42 by analogy with scientific research. IB: Cl. 41 contains services that provide education or training, i.e., the practical aspects of education. There is currently no basis in Cl. 41 that would justify the inclusion of research services in the field of education. This is why the Mark and Design Classifications Sector has always advised to classify research services in the field of education, and also in the field of sociology, philosophy, history, literature, etc. in Cl. 42 as "services in relation to the theoretical [and practical] aspects of complex fields of activities;", although we understand that this wording is not absolutely clear. In fact, in the absence of clearer guidance in the NCL, we advise to classify all research services in Cl. 42, except for those that appear expressly in a different class in the Alphabetical List. If this proposal is approved in Cl. 41, we would suggest that the class heading of Cl. 41 be changed to somehow include research in the field of education, e.g., by changing "Education;" to "Education and research services relating thereto;" However, the question still remains where to classify research services in the field of sociology, philosophy, history, linguistics, literature, etc. Cl. 41 because of the cultural/educational components of the subject matter? GENERAL COMMENTS FROM OFFICES

IL: We agree as to the need for greater clarity regarding the classification of "research service", however, the current proposal isn't sufficient and may cause confusion as per the justification behind each classification, we believe that distinguishing research services should be made based on the distinction between academic research in physical and technological sciences in class 42 as well as Humanities and social studies in class 41 both as academic disciplines, vs research services as a professional service provided for business/financial/legal purposes and classified accordingly.

FR: La proposition de clarification est intéressante car de nombreux services de recherches nous posent des problèmes de classement.

Cependant, si certaines des propositions faites paraissent clairement relever de la classe indiquée (ex : « financial research, medical research », « physics research » ou encore « industrial analysis and industrial research services ») en revanche d'autres propositions nous semblent beaucoup trop vagues et/ou pourraient relever de classes différentes de celles indiquées.

Tel est le cas notamment de « research in the field of welding » pourquoi la classe 40 ne conviendrait-elle pas? Il en va de même pour « research on building construction » qui pourrait tout aussi bien relever de la classe 37 comme tous les autres services relatifs à la construction.

Enfin les services de « research on food » sont à notre sens beaucoup trop larges pour être acceptables en l'état et, a fortiori, être classés.

Nous ne pouvons donc malheureusement pas soutenir globalement cette proposition.
