At its sixth session, held in December 2001, the IPC Revision Working Group requested the International Bureau to prepare and publish a list of all references from core level entries to advanced level entries which would require intellectual correction. The Working Group further agreed to consider at its seventh session the distribution of work concerned with the intellectual correction of references on the basis of that list (see document IPC/WG/6/5, paragraph 17).
