1. TheCredentialsCommittee("theCommittee"),establishedonDecember7,2000,by theDiplomaticConferenceontheProtectionofAudiovisualPerformances,meton December8,2000.

2. The delegation softhe following States, elected members of the Committee by the Diplomatic Conference, attended the meeting: Bulgaria, China, Costa Rica, Luxembourg, Malaysia, Morocco and Ukraine.

3. ThePresidentoftheCommittee,electedbytheDiplomatic Conference,was Mr.DimiterGantchev(Bulgaria).TheVice -Presidents,electedbytheDiplomatic Conference,wereMs.ChristianeDaleiden-Distefano(Luxembourg)andMr. RajaRezaRaja ZaibShah(Malaysia).

4. InaccordancewithRule 9(1)oftheR ulesofProcedureadoptedbytheConferenceon December7,2000(documentIAVP/DC/5;"theRulesofProcedure"),theCommittee examinedthecredentials,fullpowers,lettersorotherdocumentsofappointmentpresentedfor thepurposesofRules 6and 7bydelegationsoftheStatesmembersoftheWorldIntellectual PropertyOrganization("WIPO"),participatingintheConferenceinaccordancewith Rule2(1)(i)oftheRulesofProcedure("theMemberDelegations"),bytheDelegationofthe

EuropeanCommunity, participating in the Conference in accordance with Rule 2(1)(ii) of the Rules of Procedure ("the Special Delegation"), and by delegations of States members of the United Nations other than the States members of WIPO, participating in the Conference in accordance with Rule 2(1)(iii) of the Rules of Procedure ("the Observer Delegations"), as well as by the representatives of intergovernmental and non -governmental organizations, participating in the Conference in accordance with Rule 2(1)(iv) of the Rules of Procedure ("the Observer Delegations").

5. Onthebasisoftheinformationprovided by the Secretaria tast other practice prevailing in other diplomatic conferences, and in particular indiplomatic conferences convened by WIPO, the Committee decided to recommend to the Conference, meeting in Plenary, that the following criteria should be applied by the Committee in its examination of, and should govern the decision of the Conference on, the credentials, full powers, letters or other documents presented for the purposes of Rules 6 and 7 of the Rules of Procedure:

(i) asfarasanyStateisconcerned,itsdelegation'scredentialsandfullpowers shouldbeacceptediftheyweresignedbythatState'sHeadofState,HeadofGovernmentor MinisterforForeignAffairs;credentials,butnotfullpowers,shouldbeacceptediftheywere containedina *noteverbale* orletterofthatState'sPermanentRepresentativeinGenevaorin a *noteverbale* ofthatState'sMinistryofForeignAffairsoritsPermanentMissioninGeneva andshouldnototherwisebeaccepted;inparticular,acommunicationemanatingfroma MinisterotherthantheMinisterforForeignAffairs,orfromanofficialotherthanthe PermanentRepresentativeorChargéd'affairesa.i.inGeneva,shouldnotbetreatedas credentials;

(ii) asfarasanyOrganizationisconcerned,itsrepresentative'sletterorother documentofappointmentshouldbeacceptedifitwassignedbytheHead(DirectorGeneral, SecretaryGeneralorPresident)orDeputyHeadorofficialresponsibleforexternalaffairsof theOrganization;

(iii) facsimileandtelexcommunicationsshouldbeacceptedif,astotheirsource, therequirementsstatedinpoints (i)and (ii)werefulfilled.

6. PendingafinaldecisionbytheConferen ce,meetinginPlenary,onthesaidcriteria,the Committeedecidedtoapplythosecriteriatothedocumentsreceivedbyit.
