Web services developed by EAPO

- **EAPO-ONLINE e-filing and document exchange tool**
online filing, applicant's dashboard, notifications, application-related documents' exchange
- **Common Eurasian IP Register**
integration with open IP registers of:
 - Intellectual Property Agency of Azerbaijan – done
 - Kyrgyzpatent – in progress
 - Rospatent – in progress
- **General Documents Exchange Tool**
secure document exchange between EAPO and national IPOs of EAPC Contracting States

Future plans



- **Common Eurasian IP Register**
integration with all national IPOs of EAPC Contracting States
- **Eurasian Pharmaceutical Register**
national patent data updates
- **EAPO Project on the Electronic Exchange of Priority Documents**
secure document exchange platform
- **Legal Status of Eurasian Patents (for each EAPC Contracting State)**
information tool for national IPOs of EAPC Contracting States

... and full compatibility with ST.90

ST. 90 recommendations in EAPO APIs

Provisions of ST. 90 followed by EAPO

- A server response is the representation of a resource
- Every request is independent from previous one
- Standard contract of HTTP methods: GET – retrieve data, POST – submit new data, PUT – update, DELETE – delete data
- Response body serialization to JSON or XML
- Standard response codes (200, 404, 403, 500 etc.)
- Resource path has hierarchical order, stand-alone resources are base paths, while dependent resources are subpaths
- Response with list of entities contains hypermedia links for each entity
- Pagination support
- Data sorting support
- Error responses contain technical details of error but avoid sharing security-sensitive information
- Open resources are available without authorization while others are available with authorization and authentication
- Standard OpenAPI documentation format

Provisions of ST. 90 not fully followed in current EAPO tools

- Versioning (resource link contains API version that server supports (deprecated and new versions of the API))
- Caching of immutable GET requests
- 4 • Headers for localized data (for example “Accept-Language”)

Use of APIs of other IP offices



- **PATENTSCOPE** (integration with EAPO e-filing, publication, e-dossier tools)
- **WIPO Sequence Validator** (local instance, integration with e-filing tool)
- **WIPO Translate** (local instance, integration with EAPATIS search system and publication server)
- **WIPO CASE** (in progress, documents upload and download)
- **The New Search Platform of Rospatent** (integration with EAPATIS search system)
