ANNOTATED DRAFT AGENDA

1. Opening of the Twelfth Session

<u>Brief description</u>: A representative of the Director General will open the session and deliver his welcoming remarks. This will be followed my additional remarks from the Secretariat.

Brief description: Two Vice-Chairs will be elected.

This Task Force is responsible for developing and maintaining eXtensible Markup Language (XML) components that comprise WIPO Standard ST.36, ST.66 ST.86 and ST.96. The focus of development work since the last session of the CWS was to develop trademark and industrial design legal status XML schemas. Version 8.0 is planned for release on October 1, 2024, and is planned to include the final draft versions of these schemas.

Since the last session, the Legal Status Task Force has been working to improve Annex II of WIPO ST.87, resulting from its collaboration with the XML4IP Task Force to produce XML schemas to

capture industrial design legal status data. In light of these updates, the Task Force Leader also proposes revisions to WIPO Standards ST.27 and ST.61, to keep all three legal status Standards aligned.

<u>Brief description:</u> This document captures a proposal by the International Bureau to revise WIPO Standards ST.3, ST.9 and ST.80. The proposed revisions to WIPO ST.80 firstly aim to align the Standard with changes that were made to the legal framework of the Hague System since the last revision of WIPO ST.80, and secondly to make minor corrections to the terminology and references used under the Hague System, and thirdly to enhance the understanding of published information. The proposed revisions to WIPO ST.3 and ST.9 are related to the proposed revisions to WIPO ST.80 and aim to correct INID codes and references in relation to the Hague, Madrid and PCT Systems.

The other proposed revisions are to ensure that the three Standards remain aligned.
