


The present document sets out the evolution of accessions to treaties administered by the World Intellectual Property Organization (WIPO) from January 1, 1970, to September 13, 2005.

#### (i) Convention Establishing the World Intellectual Property Organization (1967)





#### (ii) Paris Convention for the Protection of Industrial Property (1883)









## (vi) Hague Agreement Concerning the International Registration of Industrial designs (1925)





















### (xv) Convention Relating to the Distribution of Programme-Carrying Signals Transmitted by Satellite (1974)








#### (xviii) Trademark Law Treaty (TLT) (1994)


Belgium will become bound by the Treaty three months after the deposit of the instrument of ratification of Luxembourg.


