As we meet today, the world is confronted with complex economic, social and environmental challenges. WIPO offers Members States a valuable multilateral platform where we can work closely together, strengthen trust, and enhance partnerships to overcome these challenges.

A new and innovative dynamic is needed to overcome the negative shocks of the pandemic and contemporary global challenges that disproportionately affect developing countries like Sierra Leone. Today, innovation and technological advancements are changing the way we live and do business. Intellectual Property (IP) plays a critical role in helping businesses, particularly SMEs, as well as youth and women innovators to protect, manage and transact their IP and intangible assets for growth. The government of Sierra Leone recognizes that Intellectual

In connection with this, this year in collaboration with stakeholders, including academic institutions and private sector, we celebrated international IP day with a particular focus on women's participation in innovation and creativity.

In all of our communities Women's entrepreneurship, innovation and creativity foster technological advancement, enriches culture, and contribute to economic growth. However, United Nations figures from a 2022 report indicate that women's exclusion from the digital world has contributed to a \$ 1 trillion loss in the gross domestic product of low-and middle-income countries in the last decade. Sierra Leone under the leadership of H.E. President Julius Madda Bio has been championing gender equality and women's empowerment as a crucial element of attaining sustainable peace and social and economic development in the country.

To this end, we have been working closely with WIPO to develop a well-functioning IP and innovation infrastructure in Sierra Leone to meet our Sustainable Development Goals and bridge the digital divide. We would like to sincerely thank WIPO and ARIPO for their continued support, guidance and assistance.

We need focused support mechanisms that facilitate technology transfer and capacity development from WIPO and its Member States to improve our national IP ecosystems, particularly in support of women and girls, and deliver concrete impact driven results in line with our development agenda, such as agriculture, health, and renewable energy.

Now more than ever we cannot afford to lose the innovative potential of any group or community!
