SUMMARY

This document brings up to date the identification of the member countries of some of the bodies convened, as far as such identification is possible at the time of writing this document.

Introduction

- 1. This document brings up to date the information given in paragraphs 7, 8, 14, 15, 22, 23, 29 and 30, of document AB/I/1.Rev., as to which States qualify for membership in the Assemblies of the Paris, Berne and Nice Unions, the Conferences of Representatives of the same Unions, and the General Assembly and Conference of WIPO.
- 2. In the case of the three Unions, the left-hand columns show the States which qualify for membership in the Assembly ("Group A") and the right-hand columns show the States which qualify for membership in the Conference of Representatives ("Group B"). An asterisk before the name of the State indicates that that State qualifies by virtue of the five-year privilege described in paragraph 6 of document AB/I/1.Rev.
- 3. The information is based on the situation at September 19, 1970.
