8. Modification of the maximum annual amount of the expenditure of the International Bureau as far as the Berne Unions is concerned and as far as such expenditure is to be borne by the countries members of the Conference of Representatives, meeting as a Conference of Plenipotentiaries.

9. Consideration of comments concerning the preparation for a conference of revision of the Berne Union

It is proposed that this item of the agenda be dealt with in a joint meeting with the Assembly of the Berne Union.
