Amendments to the Staff Regulations and Rules

- 2. In conjunction with the increase in the maximum annual amount of the education grant (document CCIU/VII/7, paragraph 13) laid down in Rule 3.11.1(C), the grant for tuition in the mother tongue was raised from 1,512 to 2,160 Swiss francs per year for individual instruction and from 756 to 1,080 Swiss francs per year for group language tuition. The provisions governing this matter appear in item (e) of Rule 3.11.1(C).
- 3. Article 3.12 concerning dependency allowances was revised with retroactive effect from July 1, 1969. The principal amendment consisted in raising the amounts of the allowances awarded to staff members in the general services category, following an increase made by the international organizations in Geneva applying the "Common System".
 - The allowance for a spouse was raised from 900 to 1,500 Swiss francs per year.
 - The allowance for each dependent child was raised from 960 to 1,300 Swiss francs per year.
 - The allowance for a dependent parent, brother or sister was raised from 450 to 750 Swiss francs per year.

This regulation has also been amended in order to bring the conditions of grant of such allowances into full conformity with the corresponding United Nations provisions.

4. The correction of certain provisions of Chapter IX ("separation from service") that are mentioned in paragraph 16 of document CCIU/VII/7 also apply to Articles/9.1 and 9.8.
