4. Election of the Officers
According to the proposed rules of procedure
of the Assembly (document AB/I/2), one Chairman
and two Vice-Chairmen.
5. Election of the ordinary members of the Executive
Committee of the Paris Union
See Paris (Stockholm) Convention, Articles 13(2)(a)(iv)
and 14(2)(a),(3),(4), and the proposed rules of
procedure (document AB/I/2) of the Executive Committee.
6. Participation in the election of the Director General
See WIPO Convention, Article 6(3)(g), and documents
AB/I/12, 17 and 22.

7. Review and approval of the reports and activities (since December 1967) of the Director of BIRPI concerning the Paris Union.

See Paris (Stockholm) Convention, Article 13(2) (a) (iii), and documents AB/I/3 and AB/I/4.

It is proposed that this item of the agenda be dealt with in a joint meeting with the Conference of Representatives of the Paris Union.

- 8.(a) Determination of the program and adoption of the triennial budget (1971 to 1973) of the Paris Union

See Paris (Stockholm) Convention, Article 13(2) (a) (vi), and documents AB/I/7 and AB/I/8.

It is proposed that this item of the agenda be dealt with in a joint meeting with the WIPO General Assembly, the WIPO Conference, the Conferences of Representatives of the Paris, Berne and Nice Unions, and the Assemblies of the Berne and Nice Unions.

- (b) Universal Agreement on Marks

See the proposal of the United States of America (document AB/I/20).

It is proposed that this item of the agenda be dealt with in a joint meeting with the Conference of Representatives, and the Executive Committee, of the Paris Union.

- (c) Developing Countries and Patent Licensing

See the proposal of Sweden (document AB/I/21).

It is proposed that this item of the agenda be dealt with in a joint meeting with the Conference of Representatives, and the Executive Committee, of the Paris Union.

- 9.(a) Adoption of a resolution concerning special contributions to the PCT program of 1971

See Paris (Stockholm) Convention, Article 13(2) (a) (xii), and document AB/I/11.Rev.

It is proposed that this item of the agenda be dealt with in a joint meeting with the Conference of Representatives, and the Executive Committee, of the Paris Union.

- (b) Implementation of the Resolution of the Washington Diplomatic Conference on the Patent Cooperation Treaty

See document AB/I/18.

It is proposed that this item of the agenda be dealt with in a joint meeting with the Conference of Representatives, and the Executive Committee, of the Paris Union.

10. Confirmation of ICIREPAT

See Paris (Stockholm) Convention, Article 13(2)(a)(xii), and document AB/I/13.

It is proposed that this item of the agenda be dealt with in a joint meeting with the Conference of Representatives of the Paris Union. The decision that ICIREPAT should be a Committee of Experts of the Paris Union was made by the Conference of Representatives of the Paris Union in its second session (December 1967; document CR/II/15, paragraph 22), whereas the Organizational Rules of ICIREPAT were established by the Executive Committee of the Paris Union in its fourth session (September 1968) (see document CEP/IV/18, Annex II).

11. Adoption of financial regulations

See Paris (Stockholm) Convention, Article 13(2)(a)(vii), and documents AB/I/5 and 16.

It is proposed that this item of the agenda be dealt with in a joint meeting with the General Assembly and Conference of WIPO, and the Assemblies of the Berne and Nice Unions.

12. Appointment of auditors

See Paris (Stockholm) Convention, Article 16(8), and document AB/I/6.

It is proposed that this item of the agenda be dealt with in a joint meeting with the General Assembly of WIPO and the Assemblies of the Berne and Nice Unions.

13. Admission of observers

See the proposed rules of procedure of the Assembly (document AB/I/2), and document AB/I/14.

It is proposed that this item of the agenda be dealt with in a joint meeting with the other ten bodies.
