The Chairman (Mr. Voyame) and one of the two Vice-Chairmen (Mr. Brenner), elected in 1967, are not available because of the change which has intervened in their position. If the Second Vice-Chairman (Mr. Sakai (Japan)) is available, he will open the session; otherwise, a Provisional Chairman will have to be elected.

Article 14 of the present rules of procedure provides that the Conference of Representatives may modify its rules of procedure. No details are provided for the procedure of amending except that the decision requires two-thirds of the votes cast and that abstentions are not counted (see Article 11 of the present rules of procedure).

The proposed new rules of procedure appear in document AB/I/2.

4. Election of the Officers

5. Election of the associate members of the Executive Committee of the Paris Union

6. Review of and advice on the reports and activities (since December 1967) of the Director of BIRPI concerning the Paris Union

7.(a) Establishment of a report on the foreseeable expenditure of the International Bureau for the triennial period from 1971 to 1973 as far as the Paris Union is concerned

It is proposed that this item of the agenda be dealt with in a joint meeting with the General Assembly and Conference of WIPO, the Assemblies of the Paris, Berne and Nice Unions, and the Conferences of Representatives of the Berne and Nice Unions.
