They relate to the International Convention for the Protection of Performers, Producers of Phonograms and Broadcasting Organizations (Rome, 1961; "Neighboring Rights Convention") and the Convention for the Protection of New Varieties of Plants (Paris, 1961; "UPOV Convention").
