Opening of the Session

1. The General Assembly of WIPO (hereinafter called "the General Assembly") held its first ordinary session at Geneva from September 21 to 28, 1970.
2. The following States, members of the General Assembly at the opening of the session, were represented: Belgium, Brazil, Bulgaria, Canada, Cuba, Czechoslovakia, Denmark, Finland, France, Germany (Federal Republic), Greece, Holy See, Hungary, Ireland, Israel, Italy, Ivory Coast, Japan, Luxembourg, Malta, Morocco, Netherlands, Norway, Poland, Portugal, Romania, South Africa, Soviet Union, Spain, Sweden, Switzerland, Syrian Arab Republic, Tunisia, Turkey, United Kingdom, United States of America, Upper Volta, Yugoslavia (38).
3. The States and organizations which were represented by observers are shown in the list of participants (document AB/I/INF/5).
4. The session was opened by Mr. Edward Armitage (United Kingdom), Chairman of the Ad Hoc Committee of the Whole (see document AB/I/33, paragraph 5), acting as provisional Chairman of the General Assembly.

Agenda

5. The agenda was adopted as proposed in document WO/GA/I/1.Rev. and was later completed by a new item, "Headquarters Building."

Approval of Measures Concerning the Administration of Certain International Agreements

13. The discussions were based on document WO/GA/I/2.

14. The Delegation of the United States of America stated that the fact that it was ready to approve the proposal that WIPO participate in the administration of the Convention for the Protection of New Plant Varieties should not be considered as a precedent indicating that its Government was ready to approve of international treaties which did not guarantee the strict application of the principle of national treatment. That principle was fundamental and had been adopted by all other treaties administered by WIPO. The Director General pointed out that the Convention for the Protection of New Plant Varieties recognized the said principle but only among its member States.

15. The General Assembly unanimously approved participation by WIPO in the administration of the International (Rome) Convention for the Protection of Performers, Producers of Phonograms and Broadcasting Organizations and of the Convention for the Protection of New Plant Varieties and noted with approval the other suggestions contained in document WO/GA/I/2.

#### Determination of the Working Languages of the International Bureau

16. The discussions were based on document WO/GA/I/3.

17. The Delegation of the Soviet Union, supported by those of Czechoslovakia and Bulgaria, proposed that Russian be one of the languages in which the International Bureau conducts correspondence with States (document WO/GA/I/3, paragraph 7).

18. The Director General having stated that this was essentially a financial question, the General Assembly entrusted him, with a view to taking a decision on this point at a later date, with the preparation of a report on the financial consequences of the introduction of Russian as one of the languages in which the International Bureau conducts correspondence with States. At the request of the Delegation of Germany (Federal Republic), it was decided that this report would also deal with the financial implications of the introduction, in the same circumstances, of the German language.

19. The Delegation of Finland suggested that the International Bureau conduct correspondence with States in English as well as in French in connection with the Madrid, Hague and Lisbon Unions, whereupon the Director General explained that none of the States members of these Unions was of English language or had requested the International Bureau to correspond with it in that language; it was possible, however, to make exceptions to this rule, and exceptions had indeed been made; for instance, the documents

prepared for the purposes of the revision of the Madrid Agreement Concerning the International Registration of Marks had been distributed in English as well as in French, and this procedure would continue to apply in the future.

20. Subject to what is stated in paragraph 18, above, the General Assembly unanimously approved the proposals contained in document WO/GA/I/3.
