# Corrections

- Correction Notifications may relate to the following non-exhaustive list of issues:
  - Name/address of the holder
  - List of goods/services
  - Add/delete a class or classes of goods/services
  - Date of IR/SD
  - Representation of mark
  - Mark type
  - Class Number



## **Refusal following a Correction**

- If re-examination of IR/SD is required :
  - Inform IB to disregard the previous Provisional Refusal of Protection issued
  - Issue a new refusal titled "<u>Provisional Refusal of Protection Following a Correction</u> <u>Notice</u>"
    - Deadline to refuse 18 months from the notification date of correction.





### Notifications from WIPO

- WIPO uploads the following information on FTP server:
  - Weekly Retrieval: XML/PDF notifications relating to Madrid IR/SDs, Renewals and Rectifications
