## Designated Contracting Party (2)

- Refusals and Oppositions
  - Grounds
  - Time limits to issue refusals
  - Time limits to respond
  - Calculation of time limits extendable?
  - Review or appeal?
  - Time limit to file opposition
  - Local Representative?



#### Designated Contracting Party (3)

- Grant of Protection
  - Form
  - Certificate?
- Use Requirements: Intention to Use, Actual Use
- Invalidations
  - Authority, Eligibility, Requirements
     (Representation, Time limit to file request)
