# 国际注册转让（商标所有权变更）概述

- ❖ 商标所有权可能因各种原因、以不同方式发生变更：合同转让；法院判决；或法律的实施，如继承、破产等；企业合并可能自动发生所有权变更，等等。
- ❖ 转让在国际注册簿登记之前，国际注册的原所有人称为“注册人”或“转让人”，新所有人称为“受让人”。转让一经登记，受让人成为国际注册的注册人。

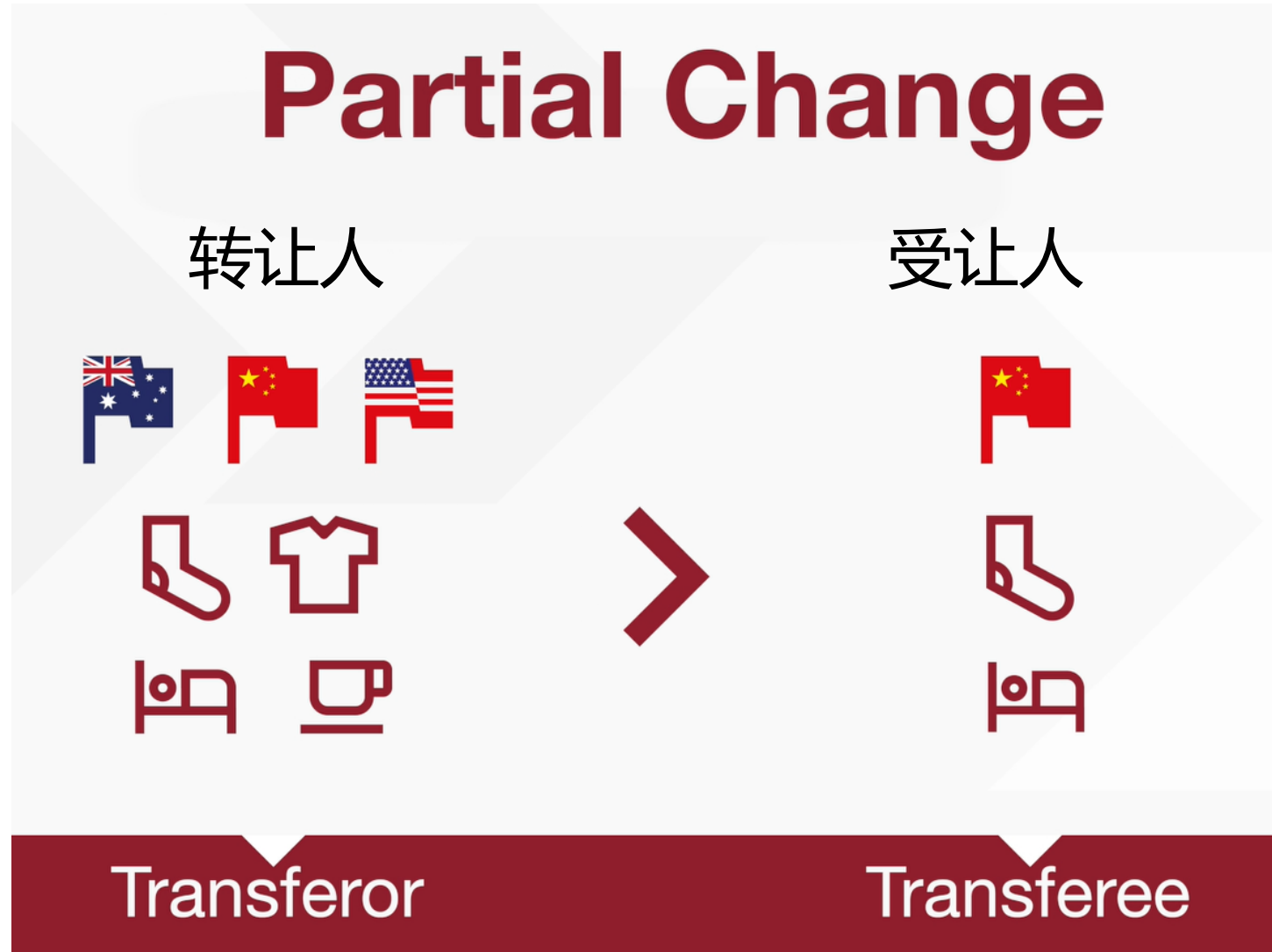

# 关于指定一个代理人

- ❖ 如果受让人希望指定一个代理人，受让人必须签名，否则代理人指定将被取消。
- ❖ 必须为代理人提供电子邮件地址，国际局的所有通信将发送到该邮件地址。
- ❖ 如果没有登记代理人，国际局的所有通信将直接发送到受让人的电子邮件地址。
- ❖ 受让人（新的注册人）随后可以通过在线“管理代理人”或使用表格MM12指定代理人。

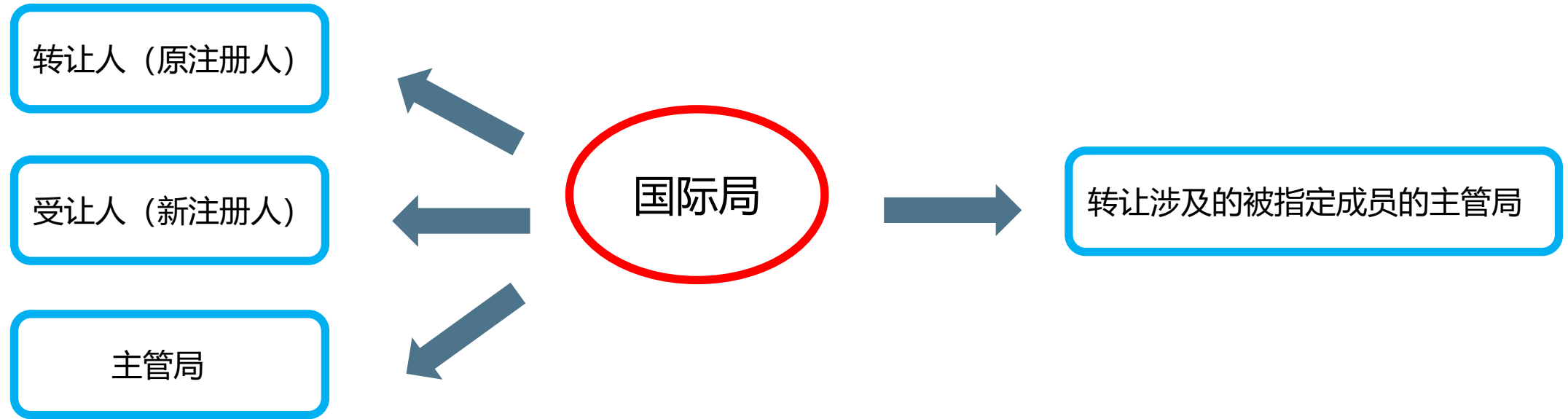
- ❖ 特别要注意的是，在全部转让的情况下，如果不重新指定代理人，那么国际转让登记后，目前登记的代理人将被注销。即使受让人和转让人的代理人仍是同一个，仍需重新指定。

- ❖ 如果是部分转让的情况下，如果不重新指定代理人，原国际注册号登记的代理人将保留，而因转让产生的新国际注册号下，将没有代理人信息。

# 转让申请的不规范

- ❖ 申请不符合适用的要求时，国际局将通知注册人。申请通过主管局提交的，还将通知该局。
- ❖ 不规范必须在通知之日起三个月内补正，否则申请视为放弃。已付款将在扣除规费的一半后退还付款人。
- ❖ 申请通过主管局提交的，注册人或受让人应当核实该局是否打算对不规范进行补正，还是应由注册人或受让人补正。

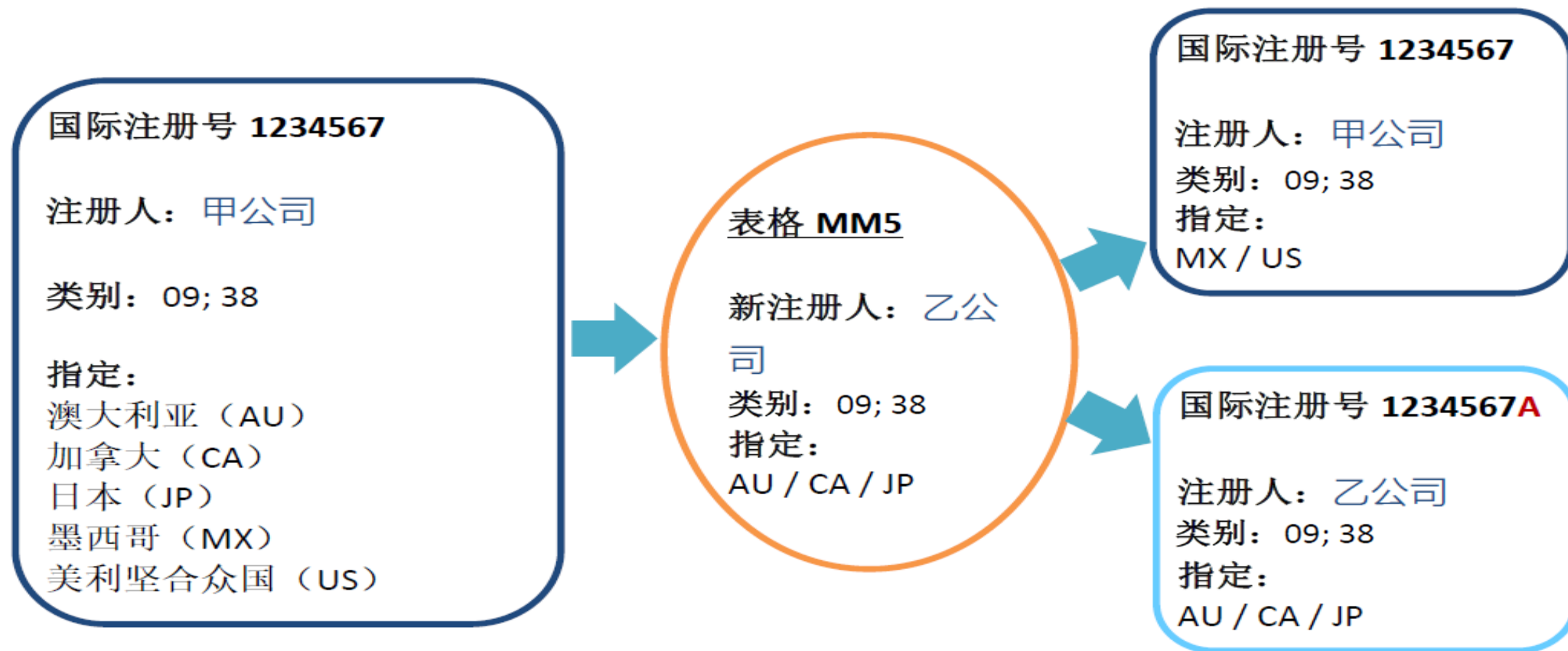

# 部分转让的登记

- ❖ 部分转让的情况下，被转让部分将作为另一项国际注册登记。这项新国际注册的号码与原注册一样，加上一个大写字母，并将在《公告》中公布。
- ❖ 产生的多个国际注册均可进一步进行所有权全部或部分变更以及登记后期指定。
- ❖ 产生的多个国际注册需分别进行续展。



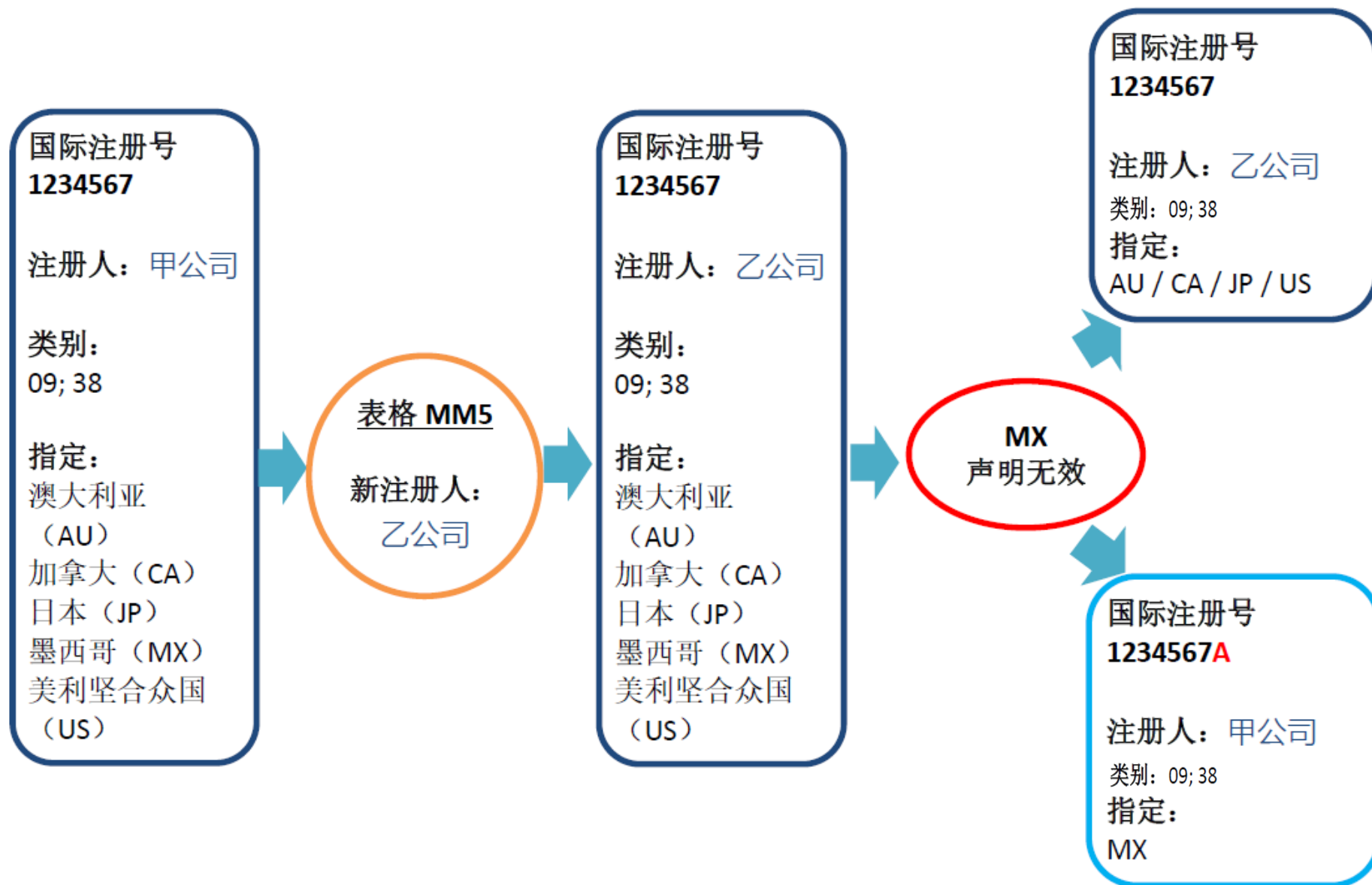

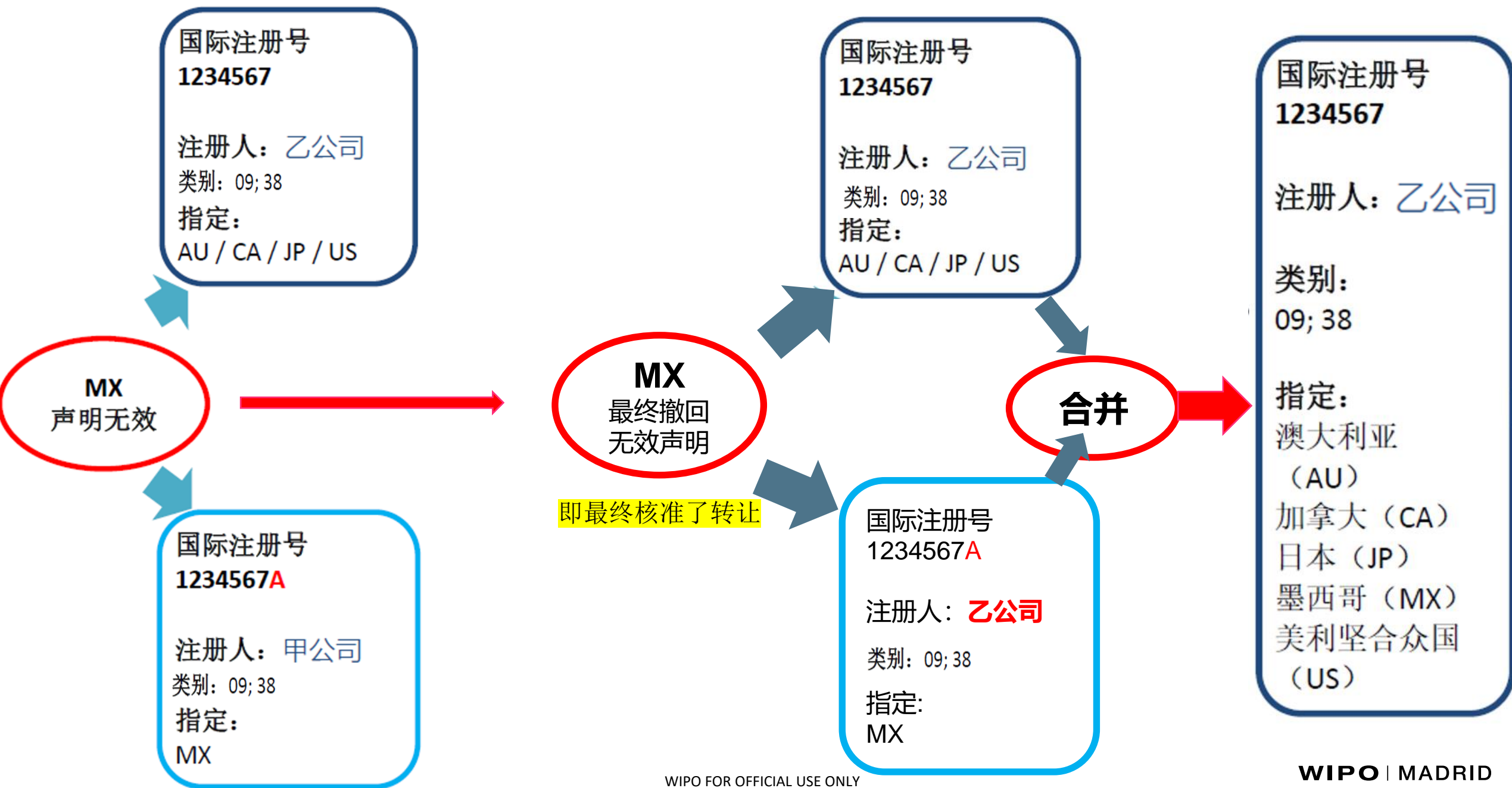


# 转让无效声明

- ❖ WIPO不对转让做出法律决定，转让申请的效力由被指定成员主管局确定，由其适用的国家法律决定。
- ❖ 被指定成员的主管局可以声明该转让在其领土上无效，且必须在国际局通知之日起18个月届满前发给国际局。
- ❖ 主管局必须在声明中说明所有权变更无效的理由，法律相应的主要条款，以及可否对声明提起复审或上诉。
- ❖ 主管局把无效声明通知国际局，国际局将通知转让申请的提交方（注册人或主管局）和新注册人。
- ❖ 在国际注册簿中，无效声明的效果是，对该成员，将产生一个新的国际注册号（加大写字母），有关国际注册仍在转让人（原注册人）的名下。

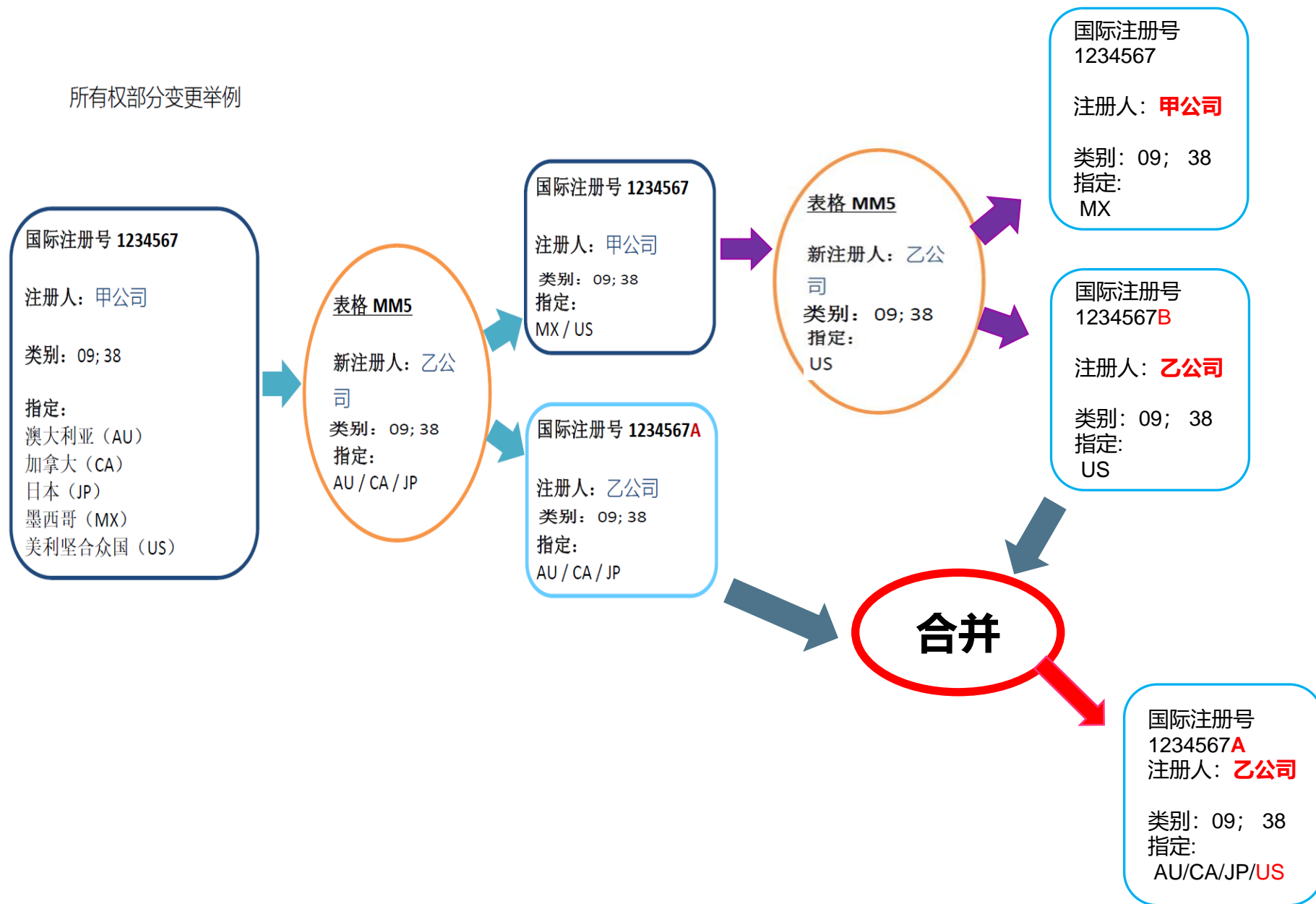




# 因转让产生的国际注册的合并

- ❖ 部分转让，或者被指定成员发出转让无效的声明，可能产生单独的国际注册。
- ❖ 因转让产生的两项或更多国际注册，如果被登记在同一注册人名下，该注册人可以向国际局申请合并登记。
- ❖ 只能合并从同一个国际注册中分出的两个或多个国际注册。如果国际注册来自不同的国际申请，不能合并。
- ❖ 因转让产生的合并申请（MM23）可以由注册人直接向国际局提交，也可通过注册人所属成员的主管局提交。登记这种合并是免费的。

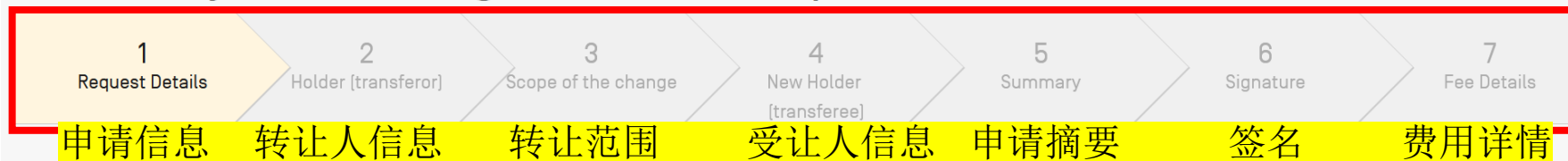

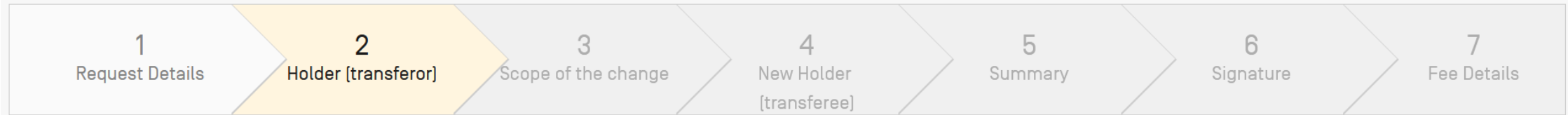
