

(6) Shares of the top foreign destinations are based on absolute count of applications, that is, one application filed at a regional office is counted as one application only. (7) One application filed at the Eurasian Patent Organization, the African Intellectual Property Organization, the Benelux Office for Intellectual Property, the European Union Intellectual Property Office or the Patent Office of the Cooperation Council for the Arab States of the Gulf is multiplied by the corresponding number of member state.
