Madam, Sir,

During its first session, in May 2001, the Standards and Documentation Working Group (SDWG) considered background and scope of Task No. 20 "Prepare a recommendation on how figurative elements of marks should be captured in electronic form and how they should be displayed on visual display units." The SDWG agreed on certain steps to be taken before a decision could be made as to the continuation of the task (see Annex III, page 13 of document SCIT/SDWG/1/9 Prov.).

As a follow-up to the decision by the SDWG, the Secretariat has prepared, in cooperation with the United States Patent and Trademark Office and the Office for Harmonization in the Internal Market, a Questionnaire to collect information from industrial property offices on formats currently in use for figurative elements of marks. The Questionnaire is enclosed as an Annex to this Circular.

INTRODUCTION

 analyze the different standards/techniques applied by the IPOs of the various Member
 States and by regional organizations and to determine the feasibility of establishing a
 WIPO recommendation on how figurative elements of marks should be captured in
 electronic form.
- 2. The proposal to develop a WIPO recommendation on the above-mentioned subject matter was made in view of the fact that, with the entry into force of the Madrid Protocol and the ensuring internationalization of trademark data exchange, standards are needed to guarantee the exchange of highly standardized data in impeccable quality.
