Ref . your message under subject SCIT Re-structuring, please note our comments:

1.Introduction

According to the initial mandate of SCIT, as defined in document A/32/3, dated February 1998, the Portuguese delegation agrees with the substitution of the existing SCIT for an advisory group, composed by experts from the member states and non governmental international organisations (e.g. EPO, OHIM,...)

2. Advisory Group on Information Technology

The Portuguese delegation agrees with the organisation and working methods of this group.

3. Standing Committee on Technical Standards and Documentation

The Portuguese delegation does not agree, definitively, with the constitution of this committee as in the proposed version:

- a) All the Members States should be represented
- b) This committee should report directly to the general assembly, which would promulgate the standards proposed by the committee.
- c) For a best development of work, the International Bureau should present to the Committee the basic documents which would be analysed and discussed by the members of the referred Committee.
- d) In case of exceptional difficulty, the Committee could stablish restricted Working Groups within itself for executing technical tasks of great complexity.
- e) The assistance of external experts should be exclusively reserved to the International Bureau for occasional elaboration of more complex basic documents.
