During the pandemic libraries had to close their library buildings at several instances. Instead, they offered increased amounts of e-media (and especially e-books) to their users, as this was the only way to ensure access to knowledge and information. However:

- libraries are still not able to access many new e-book releases, due to the fact that there is no legal basis for e-lending in German copyright legislation;
- According to § 60e Abs. 4 UrhG, the works from the inventory of the library can only be made available at the terminals within the library and not through for example the network of the university outside the university campus. This means that for example textbooks are often not available for university library users.

Many libraries offer campus delivery services. As there are legal uncertainties about the permitted amounts and remuneration, this has however not resolved the lack of access to printed media.

Universities have during the pandemic switched to digital education and are using a range of digital platforms for this. Newspaper articles can however not be made available for digital education, as they are excluded from the relevant provision (§ 60a UrhG). This has further reduced access to printed media.
