Madam, Sir,

1. This Circular concerns proposals for change to the Standard for the Electronic Filing and Processing of International Applications under Annex F of the Administrative Instructions under the Patent Cooperation Treaty (PCT)) which, if adopted, will result in modifications of that Annex . It is being sent, for the purposes of consultation pursuant to Rule 89.2(b) of the Regulations under the PCT, and under the change procedure provided for in section 2.5.5 of Annex F (expedited consideration of proposals for change), to the national and regional patent Offices of, or acting for, all PCT Contracting States, including all receiving Offices, International Searching Authorities, International Preliminary Examining Authorities, and designated and elected Offices, and to interested intergovernmental organizations, as well as to certain non-governmental organizations representing users of the PCT system.

2. The International Bureau has received and prepared a number of proposals for change to the standard for the electronic filing and processing of international applications relating to additions to the DTDs in view of the entry into force, on July 1, 2008, of a number of amendments to the PCT Regulations. The proposals are available on WIPO's Website as an annex to the following proposals for change (PFC) files (see *http://www.wipo.int/efiling_standard/en/pfc_files.htm*):

The International Bureau has also received a number of proposals for change to the set of International Common Elements (ICEs) specified in WIPO Standard ST.36, which do not also form part of Annex F of the Administrative Instructions under the PCT; these proposals will be reviewed as part of the ST.36 Task Force activities and are not subject to this consultation for modifications of Annex F.
