Madam, Sir,

1. This Circular concerns proposals for change to the Standard for the Electronic Filing and Processing of International Applications under Annex F of the Administrative Instructions under the Patent Cooperation Treaty (PCT) which, if adopted, will result in modifications of that Annex. It is being sent, for the purposes of consultation pursuant to Rule 89.2(b) of the Regulations under the PCT, and under the change procedure provided for in section 2.5.5 of Annex F (expedited consideration of proposals for change), to the national and regional patent Offices of, or acting for, all PCT Contracting States, including all receiving Offices, International Searching Authorities, International Preliminary Examining Authorities, and designated and elected Offices, and to interested intergovernmental organizations, as well as to certain non-governmental organizations representing users of the PCT system.

2. The International Bureau has prepared additional proposals for change to the Standard for the Electronic Filing and Processing of International applications, the first relating to additions to the DTDs in view of the entry into force, on July 1, 2008, of additional amendments to the PCT administrative instructions relating to the specification of the desired nature of utilization of electronic mail addresses supplied by the applicant at the time of filing; consultation regarding the revision of the PCT request form will follow shortly. The second proposal for change addresses an earlier implementation issue regarding data entry for sequence listings and tables supplied in electronic form.
