Madam, Sir,

I have great pleasure to inform you that, on February 2, 2017, the International Bureau of the World Intellectual Property Organization (WIPO) published the 3 millionth international application filed under the Patent Cooperation Treaty (PCT). This is an important milestone in the history of the Treaty and of the Organization.

From modest beginnings in 1978, with initially 18 members, the PCT has grown into the central pillar of the international patent system, the primary vehicle for applicants seeking patent protection internationally in any of the PCT's current 151 Member States and one of the best examples of successful multilateral work sharing and cooperation in the field of intellectual property.

In its almost 39 years of operations, the number of international applications filed has steadily increased from 459 applications during its first year to more than 230,000 applications in 2016, far exceeding even the most optimistic expectations of the founders of the PCT who created the system in the 1960s. Today, it is one of WIPO's key assets, accounting for 76 per cent of its revenue and enabling the financing of the development cooperation program of the Organization and of many of its other activities. I have every expectation that its growth and vitality will continue. The PCT's success is a tribute to the vision of the PCT's founders who, more than four decades ago, foresaw the value in providing a global service to assist innovators in seeking multinational patent protection for their inventions.

It is intended to provide "food for thought" on broad directions and priorities for future work aimed at further improving the system.

The International Bureau remains dedicated to working with all PCT stakeholders to further improve the functioning of the PCT System, for the common benefit of Member States, Offices, applicants and third parties alike.
