Madam, Sir,

This Circular is addressed to your Office in its capacity as a receiving Office, International Searching Authority, International Preliminary Examining Authority and/or designated or elected Office under the Patent Cooperation Treaty (PCT). It is also being sent to interested intergovernmental organizations as well as certain non-governmental organizations representing users of the PCT system.

This Circular concerns the conclusion of consultations, notified in Circular C. PCT 1632, regarding proposals for change to the Standard for the Electronic Filing and Processing of International Applications under the PCT (Annex F of the Administrative Instructions).

Description of changes

Proposed changes to Annex F and its appendices are set out in the following Proposal for Change (PFC) files

Conclusion of consultations

Consultations under PCT Rule 89.2 have been conducted in accordance with the procedure set out in Section 2.5 of Annex F of the PCT Administrative Instructions.

The International Bureau of the World Intellectual Property Organization (WIPO), in light of the comments received regarding the modification of the Document Type Definitions (DTDs) referenced in the PFC files, has concluded that there were no comments regarding the proposals that required changes to be made to the draft DTDs. The International Bureau has adopted a suggestion from the German Patent and Trademark Office regarding the consistency of the terminology for ST.26 XML files in the main text of Annex F.
