1. This document describes the changes made to ST.96 Schema V3_0 to create V3_1. The ST.96 XML Schema V3_1 has been prepared primarily on the basis of issues reported in Hague IB to Office transaction XML Implementation.

5. Updated com:**EntitlementDomiciledCode** to use com:ExtendedWIPOST3CodeType. It was defined as com:NationalityCodeType in V3_0.
6. Updated com: **EntitlementEstablishmentCode** to use com:ExtendedWIPOST3CodeType. It was defined as com:NationalityCodeType in V3_0.

7. Updated com: **WIPOST3CodeType**, changed country name of country code “SZ” from “Swaziland” to “Eswatini”
8. Updated com: **ISOCountryCodeType**, changed country name of country code “SZ” from “SWAZILAND” to “ESWATINI”


9. Updated dgn: **HabitualResidenceCode** to use com:ExtendedWIPOST3CodeType. It was defined as com:NationalityCodeType in V3_0.


10. Adding optional component: com:PaymentDueDate in the element dgn:**HagueSecondPartFeePayable**.
11. Adding optional component: com:ApplicationDateTime in the dgn:**HagueApplicationType**. There is already a com:ReceivingOfficeDate, but there needs to be 2 elements to handle separately the reception date (Geneva time) and the time zone date of the applicant. This is needed to resolved time zone discrepancies.


12. Updated dgn:**HagueIBToOfficeBagType**, there is a sequence that follows a choice, which breaks the “choice”. It was subsequently removed in this release.




13. Updated dgn:**HagueSecondPartFeePaidType**, added optional element com:RecordIdentifier. This element can be used bi-directionally (Office to IB or IB to Office). When it is used from IB to Office, com:RecordIdentifier is missing. It should be optional because the element can be used in both directions.



14. Removed limit on choice in dgn:**HagueOfficeCopyBagType**. There is an unjustified limit of 10 choices in dgn:HagueOfficeCopyBagType. This must be unlimited.



15. Updated dgn:**HagueApplicationType**. Changed com:DocumentIncludedBag from required to optional. Some applications require no additional com:DocumentIncludedBag.
